There are two important developments relating to the A.S.I. Budget that need to be shared.

#1. On January 22, 2016 we received word from Thomas K. Leung that effective fiscal year 2015/16, BFS is being instructed by the President's Office to withhold the Children Center referendum portion and distribute to Children Center directly in FY 2016/17.

Total fee collected for summer and fall 2015 \$543,566.01 Less: Children center referendum (\$106,162.91)

#2. We recently received word that the University President was not going to approve the 3&9 Budget because: "...The use of retained earnings/trailer reserve contained in the budget amendment is not fiscally responsible."

Regarding both instances above we are talking with A.S.I. legal counsel as to the next course of action.

While we are determining next steps we will be operating off of the A.S.I. budget approved on August 28, 2016. Per an initial discussion between the VPF, Executive Director, and the Office Manager we identified the following priorities expenses item that require immediate budgetary attention.

- Legal Counsel \$7,000.00- Not in the Budget (Adm Area)
- 2. 2 Graphic IMac's 27"/M390/CTO- \$5,798.00 Not in the Budget (Student Gov Area)
- 3. Strategic Planning Consultant \$7500.00 Not in the Budget (Adm Area)
- 4. CSSA/CHESS Not in the Budget (Student Gov Area)
- 5. Club Funding Not in the Budget (Student & Univ Support Area)
- 6. Tablet Purchase \$23,500.00 Not in the Budget (Student Gov Area)

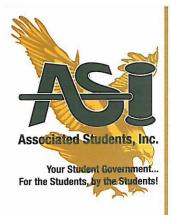
As of 2/17/16 we were able to identify \$43,522.00 in potential savings from salaries, GIA, Student Book Voucher Program, and scholarships.
