Housing insecurity/homelessness is an increasing severe reality facing many Cal State LA students. Across campus, faculty, staff, program offices, and fellow students are sharing concerns for students who are struggling with homelessness or unstable housing, which can and does profoundly affect their ability to be successful in completing classes.

The Division of Student Life would like to request funding for Emergency Short-Term Housing in Student Housing. There has already been movement in this direction, and strong collaborative efforts between the Division of Student Life, Housing and Residence Life, and the University's Food and Housing Security Task Force. Details – including eligibility criteria, stay guidelines, application, etc. – are currently being worked out. We are looking at the possibility of being able to provide short-stay apartment space for up to 12 students. We are hopeful to be able to provide this option to homeless/housing insecure students by Spring semester 2018.
