1. What previous experience have you had in the area in which you are applying for?

In the 11th grade, I ran into an old neighbor, Kevin, who attended Cal State LA as a Microbiology major. Upon asking him about his experience as a Cal State LA student, he energetically raved about his undergrad research under Dr. Porter. Thanks to dedicated NSS students like Kevin, who continues to contribute to Dr. Porter's lab as a graduate student, biological research was the aspect of college I most anticipated when I graduated high school. In the fall, I quickly worked to materialize my dream by contacting six different professors to inquire about their labs. Eventually, my persistence opened up a conversation with Dr. Russo-Neustadt, whose lab researches the neurological effects of an Ashwagandha, an Indian nightshade. I soon got invited to sit in at lab meetings with her team. Being involved in scientific discussions between graduate students opened my eyes to the potential of Cal State LA's research capabilities. I feel inspired that our university is furthering the advancement of many different STEM fields. Therefore, addition to my academic experience as a Biology major, I also have experience in the College of Natural and Social Sciences as an undergraduate student involved in research efforts.

2. State briefly why are you are applying and/or are interested in this position

I am interested in being a student representative for the College of Natural and Social Sciences because I want to interact with school administrators to help strategize ways our university can not only graduate more science majors, but also prepare them for graduate programs. In my STEM classes, I always hear my classmates' concerns about class availability and grad school requirements. As a student of biology, one of Cal State LA's most impacted majors, I want to help other science-based majors have the resources necessary to graduate on time.

3. What do you feel are some of the major problems facing the students of CSULA?

During a discussion about academic planning in Honors 1010 last semester, Professor Behen discussed the campus graduation rate. He discussed that many CSULA students fail to gain their Bachelor's degree within four years. He told us about his "Soar in 4" campaign in an effort to raise the amount of students who graduate within four years. As a represent of the College of Natural and Social Sciences, I would lend my efforts to raise the graduation rate within science majors, especially impacted majors like Biology and Psychology. In addition to raising the graduation rate, I would also want to encourage science majors to seek tutoring or other out-of-classroom academic help to raise the average Science GPA to help students get accepted to graduate programs.
