I supervise my cohort in the development and execution of health huts which are designed to educate students about Alcohol, Tobacco, and Other Drugs.						

2. State briefly why are you are applying and/or are interested in this position

I am deeply passionate about Alcohol and Drug Awareness. There is no denying that alcohol and drugs are extremely relevant to college aged students and even if a student doesn't use a substance, there is a strong chance that they will encounter it at some point in their lives. Despite the ubiquity of alcohol and other drugs, people are often misinformed or simply uninformed about the topic. If selected, my goal would be to provide students with factual, practical, and relevant information in such a way that it sticks with them. I would also encourage students to educate themselves on the topic of alcohol and drug awareness by providing reputable and easy to read resources where they could seek further information. Another key aspect of my interest in this role is the fact that there is a certain stigma that can sometimes accompany the use of alcohol and other drugs. My goal would be to create a judgment free environment where this stigma does not apply, as I believe it is counter productive to a student's health and well being. Instead of stigmatizing or judging those who use alcohol and other drugs, I would want to ensure that students know the risks and implications that these substances have, and if they do choose to use them, then they should know how to do so safely.

3. What do you feel are some of the major problems facing the students of CSULA?

From my personal experience, CSULA is not regarded as a party school, nor does alcohol or drug use seem to be highly prevalent with students. Being a commuter campus, however, students are less likely to use alcohol and drugs on or near campus, making it less obvious to faculty and other students that it is being used at all. This can be problematic because it is harder for anyone to know if there is a problem facing the students of CSULA. This is why education should be provided to students so that, if they should use or encounter alcohol or drugs, they are prepared to make safe and healthy choices.


