### Ballot Language Draft #1

Since 1959, Associated Students, Inc. (ASI) has served as the official voice of students providing services and programs that meet the educational, social, recreational, and cultural needs of the Cal State LA's diverse student community.

Currently, the annual student body fee is \$53.75, as reflected by a \$26.88 per student fee in the fall semester and \$26.87 per student fee in the spring semester. ASI has not adjusted its student body fee since 1996. As such, our fee is the lowest out of the 23 campuses in the CSU System.

## **Ballot Question One:**

Obligation Options Referendum Ballot Language:

A/C:

Shall ASI uphold the 1988 & 1966 referendums to provide partial financial support to the Anna Bing Arnold Children's Center through the fixed allocation of \$5.63 per student per semester from the current ASI Student Body Fee.

D:

Shall ASI amend the 1988 & 1996 referendums that provide partial financial support to Anna Bing Arnold Children's Center to instead require a flat annual payment of (\$150-\$250K). Future amendments will be governed by Policy 206 – Reporting and Budgeting Guidelines for External Organizations Receiving over \$3,000.

E:

Shall ASI amend the 1988 & 1996 referendums that provide partial financial support to Anna Bing Arnold Children's Center to instead require a minimum annual payment of \$140K and allow the ASI Board of Directors discretion and the ability to adjust funding based on the Board priorities as outlined in Policy 206 – Reporting and Budgeting Guidelines for External Organizations Receiving Over \$3,000.

F:

Shall ASI discard the 1988 & 1966 referendums that provide partial financial support to the Anna Bing Arnold Children's Center through the fixed allocation of \$5.63 per student per semester from the current ASI Student Body Fee. Instead, the ASI Board of Directors would have full discretion to allocate the fees based on Board priorities as outlined in Policy 206 – Reporting and Budgeting Guidelines for External Organizations Receiving Over \$3,000.

#### **Question Three:**

Shall ASI index the ASI Student Body Fee annually not to exceed the percentage set by Higher Education Price Index (HEPI). The indexing would begin in 2019.

Currently, the annual student body fee is:
\$53.75 = \$26.88 per student in the fall semester and
\$26.87 per student in the spring semester.

The new annual student body fee with the index will be \$54.72 =\$27.36 per student in the fall semester and \$27.36 per student in the spring semester.

A \$.97 cent increase
