Please, briefly and accurately describe the alleged complaint:

Following Open Deliberations, which David Z did not attend, I came down to the office. David Z was talking to Jocelyn (HHS College rep) and Lily (NSS College rep/Cabinet Chair) about me in the student representative area outside of his and David G.'s office. He was giving (negative) critiques and opinions about me as the Chair stating that he had "ethical" issues with what I was requesting of my college reps (many of whom stepped forward to say they had no issues with the D-Stress incident in question) and that I wasn't completing my job and duties properly. All critiques he was stating had never been mentioned to me in any way, shape, or form. In addition to this uncomfortable situation, he has constantly either side stepped speaking to me about the restructure of my college representatives and the VPAG's senators or not taken my opinion into consideration. Throughout the semester there have been a variety of inappropriate comments about cutting pay, withholding information about GIA's, and delegating jobs and responsibilities to college reps that aren't under their job descriptions. Further clarification on the back side and supporting documents will be provided.

David Zitser, as our A.S.I. president, has created a negative culture within this organization that revolves around a lack of communication and a lack of respect toward others. The lack of communication and respect penetrates every area of this organization. Examples of the lack of respect and lack of communication are as follows:

Examples of the lack of respect can be found in the emails labeled 1-8. The situation ensued on November 19. Ashley, Debbie, and I were at the PBI SELA Summit. Ashley had sent an email to the college representatives about volunteering for Dstress. Dstress is an initiative that comes from and is paid for by the Cabinet of College Representatives. Ashley requested that all participate in our initiative and those that could not because of finals, would have to screenshot their schedule and send it to her. The purpose of this is to hold the representatives accountable for participating in their own programs and is similar to the requests that David has been making about keeping Outlook Calendars updated and available for all to see. The emails that follow from David are all in a negative tone that was not respectful of Ashley or myself. Several false claims were made in his emails: the first was that the college representatives had no say in what was happening with Dstress and that it was an event they didn't elect to have. This is false because the date chosen for Dstress was chosen by the college representatives over the summer. Ashley has also sent out multiple Groupme messages (also provided) about Dstress and even one asking about what ideas we had for the event itself. As noted by the people who replied and liked the messages, you can see that not many college representatives interacted with Ashley when she spoke about it. Another false statement he made in the emails was that he looked at CCR minutes and there was no mention of Dstress. The minutes for 2 separate meetings have been provided that show a report by Ashley where she speaks about Dstress. The minutes aren't written verbatim and there was more conversation about the event that was included in the meeting, but

not in the minutes. The second set of minutes attached included an instance of co-college collaborations to put on an additional set of Dstress events but during midterms. During the meeting we took time to talk about the structure of Dstress and to address how a midterm Dstress would work. The minutes do not reflect this, but do include that this was a topic of discussion.

The incident that led me to file the grievance occurred on November 9th after Open Deliberations. After finishing up with Neyda at Open Deliberations, I returned to the office to retrieve my belongings. The office was locked and Jocelyn, HHS college representative, came to open the door for me and informed me that David Zitser had been in the senator area talking negatively about myself to her and to Lily, NSS representative. I overheard what he was saying about me. Very loudly, he was saying that I, as a Chair for the CCR, wasn't doing my job and his issue about what ensued that morning via email was an ethical issue. He was saying that I was being unethical by supporting Ashley's original email and the initiative. He went on to give critiques about my efforts and work as a Chair. Every issue he said were issues that he never addressed with myself as my direct report and they were issues that I didn't know existed. His lack of communication and then openly giving a performance evaluation to my Vice Chair and one of my college representatives was not just disrespectful, but it was an ethical violation.

The issues with communication have stemmed as far back as before his restructure as well. His restructure of the college representatives and the senators was started and pushed forward without speaking to myself or Neyda, the VPAG. She and I have had to go to him to speak about our issues with the restructure and had difficulty feeling heard. Speaking for myself, I had approached him multiple times and spoken openly and honestly about what the restructure meant to me, but not once have I felt like my opinion was taken into account. Neyda and I have opened up a channel of communication between each other to find a solution to the issue without having

to restructure and we feel like we have a great solution. The solution we have was presented at least twice to David yet he did not take our solution into account and continued to push his restructure.

Emails 9a and 9b address what I said to David. I no longer feel comfortable with him as my direct report. There is no trust for him from my end-the lack of communication and lack of support has strained our relationship. Email 10 is his reply where he acknowledges his lack of support and communication because it is more convenient for him. This is not the way the president of this organization should behave. His purpose for the restructure is to build communication yet he has none with anybody. Intef, our Executive Director, has the responsibility to ensure David is properly advised and to support our members, and I feel he has none neither. There are several meetings where the issue of communication has been brought up and he has mentioned that communication channels need to be opened, yet I see no work on his part to help build those communication channels. I went to Intef to speak to him about the issue with David the night of the incident and he provided no immediate support. I CC'd him in the email I sent to David addressing the issues and he has yet to reply. Marcus replied, email 11, showing his understanding and support for the situation. In my email I requested a new direct report and Intef has yet to reply to that request as well. Issues with communication should not have reached this point. It is not just David's responsibility to ensure we are properly communicating with one another, but it is Intef's responsibility to do so as well. David acted unprofessionally, did not support me, and did not properly communicate with me. He acted in ways that were unethical and, I believe, violated our A.S.I. Code of Ethics.

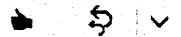

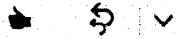

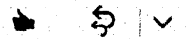

I double-checked the minutes just to make sure, but it seems that De-stress was never discussed as a cabinet in one of the meetings either as a specific discussion item or action item. In addition, if the cabinet would like to continue with the class schedule verification process, that's fine for the cabinet to do, but I as the direct report will not be utilizing the class & final exam schedules as a means of holding the college reps accountable because a college rep shouldn't be punished for not helping at an event that they are forced to participate in. If it's more like a college rep did not attend even though they said they would, that would be an entirely different case. In addition, since it is Finals week, time in-between of Finals should be used to study for Finals. This event shouldn't supersede the importance of academic success in their exams.

All-in-all, a decision made by the chair of the cabinet of college reps and Ashley can not substitute in for an official vote made by the cabinet of college reps to partake in this event, and just because this event happened last year under the cabinet of college reps doesn't result in an automatic consensus to do this event this year at all, especially that the Cabinet of College Reps would be hosting this event. Without an official say from the cabinet to do such an event and the fact that ASI work doesn't even cover the pay period that covers Finals week, I, as the college rep direct report, won't penalize any of the college reps for saying they won't attend without showing their Final exam schedule as verification. If the cabinet wants to continue with the event with the same date or not, the means of accountability that should be utilized should be if a college reps says they will be there, that they should be there, and if that if they can't, then they won't be there and not a means of accountability that forces the College Reps to participate in the event.

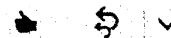

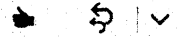

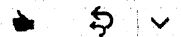

Hello David,

The purpose of this email is to address some issues of concern on my behalf. Part of my issues began yesterday morning with the string of emails related to D-Stress. I've talked to the college representatives, and you have received emails from a number of them, that addressed your concerns about college rep requirement to participate and share their schedules and I have not found one representative who has had an issue. I don't feel like, even now, I understand what the issue actually was because what we were being asked to do is exactly the same as what you have asked of us. We have been delegated responsibilities from you that required our attendance or participation somewhere and we have been asked to update and public ally share our outlook calendars which, I feel, mirrors what we were being asked of by Ashley. In addition to this, the emails from you contained incorrect information about me heading D-Stress planning, the initiative not being mentioned to college representatives, and penalization of students (which is not what we were asking for) if they could not attend the event. D-Stress is an initiative which had its date chosen by college representatives over the summer, which were discussed during 2 on 1s, which was mentioned a variety of times in our groupme conversations, was mentioned in passing to students as Ashley purchased items, and which had a written initiative proposal form filled out. The emails that were sent were negative in tone, and I feel they were disrespectful to myself and Ashley.

Issues with the email aside, following Open Deliberations, I was not comfortable with your behavior in the office. I walked into the office confronted by your voice loudly speaking negatively about the Chair of the Cabinet of College Representatives, myself, and about how I was not doing my job. You were openly and freely giving an evaluation and opinion of my work as the Chair to two college representatives (one being my Vice-Chair) before consulting me about this issue. Not once did you mention this in our 2 on 1s, in the various conversations we have throughout the week, or in any emails to me. Not once was an attempt by you made to speak with me about the quality of my work. I walked into a space where I was supposed to feel safe, supported, and welcomed and made to feel belittled and disrespected. I am hurt. I have dedicated my time and effort to the students using that office to complete my responsibilities, meet with students, and reach out to campus resources, and now I don't feel comfortable in what I considered to be my own space. I held you to a higher standard than that.

I feel like my voice in the office has been silenced. I speak to you about issues and I address topics, like the restructure, with you and feel like my feedback and my opinion isn't being considered. You are working on a restructure of my college representatives and of the VPAG's senators without communicating with us or seeking our input. You walk around us without including us in the conversation. You have also held information from A.S.I. members in regards to no longer cutting GLA's. All these conversations are being had and not communicated with the proper individuals and information isn't being shared. It feels like my voice as a student and as the Chair has no seat at the table.

Your behavior today and across the semester has been unacceptable. I am hurt, I have been disrespected, and I will no longer stand for it. I've told you time and time again how I feel, but since I feel like I am not being heard, I think it's time for a change in the way we communicate. It's time to address these issues and correct internal administration issues so that we can collectively move forward and serve the students to our fullest capacity. For the moment, however, I do not feel comfortable continuing with you as my direct report. I will be in talks with prostaff and executive officers to identify who would be the best direct report for me moving forward. From now on, I would prefer that if we meet, a prostaff and/or an executive officer is available to sit in and mediate.

Hey Kenya,

Looking back at my previous emails regarding D-Stress and the conversation I was having with the College Reps on Thursday, I do agree that the overall tone was negative and could have been handled better. I apologize for that. I lost my cool and made a mistake and took out my anger on the college reps and you especially. In addition, I also take full responsibility for not being clear with the expectations that I have for the chair of the Cabinet of College Reps and fully utilizing the role and yourself in key discussions like the restructure. Because of that, I let the situation slide out of control and escalate to a point where I became frustrated with the progress of the college reps, my own inability to fix things, and how my attempts to do so just led to more conflict and a mentality of "the College Reps vs the President" leading to a loss of trust and respect from both sides. For that, I apologize again, and I'm sorry I wasn't able to live up to your standard.

That all being said, I hope you will still be willing to meet with me in a 1-on-1 meeting with a mediator of your choosing if you would like to, so that we can hash out some of the problems the organization, you, and myself have been facing. I still do have issues with how D-Stress was planned and the state of the college reps right now, but I believe that if we sit down and think of a plan, we can solve these problems. I do admit that I tend to work alone because it's easier and faster for myself to do so and that I sometimes do view people within ASI as obstacles for myself to walk around by, but it's a constant battle within myself to not let that happen which I unfortunately let overcome me this last week. So, I'm asking you as a friend and a valued colleague to work with me because I have big plans for Spring, and I'm going to need your help to get ASI to the point where it needs to be to achieve those plans.

I understand if you need time to readjust and spend some time away from me, but I do want to talk and put to rest this feeling of us always being at each other's throats. There's a lot we can still do together, so don't let my mistake ruin your time spent with ASI. Let me carry on this burden of my mistake, and let's fix these issues plaguing ASI together.

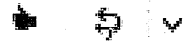

- a. Jim Goodrich— The Board will receive a special presentation on possible collaborations between the Anna Bing Arnold Child Center & A.S.I. College Reps (3:30-4:00)
- # David Zitzer: This will first be a presentation than a discussion of what better ways the college reps can support the child care center.
- # Jim Goodrich: I've come over to talk about possible collaborations, we've been looking forward to this meeting. I'm just going to talk a little bit about the children's center. I'm Jim the Assistant Director, I've been at the center for 15 years. I am also a Cal State LA alumn.
- # We're going to be celebrating our 50th year, coming up in 2018. The center's been around since 1968, our primary mission is to serve the Cal State LA community, specifically students of Cal State LA.
- # We have children at our center ranging from 6 months, all the way up to Kindergarten. We'll have at one time up to 100 children at the center. We have about 134-136 families enrolled. We offer half-day programs, full-day programs, flexible hours, specifically for students and students get priority on the waiting list. In addition to the day care services that we provide, we're also a lab site for Cal State LA, so we have a variety of departments that come over to the center for students to do lab work like student teaching. We get students from nursing, nutrition, now we have engineering students, obviously child development and charter school of education. They log in about 1000 hours a year of students doing work at our center. In addition to that we have 70 staff at the center, 50 of which are actually student assistants who are TA's for our school, which is a great addition to our program.
- # David Zitzer: Over the summer I met with Jim and Patricia, who are part of the child care center. One of the things we talked about was possible collaborations that the college reps can do with the Anna Bing Arnold Child Care Center. A few examples, the Arts & Letters Representatives can possibly help in finding music-oriented students and help set performances to the children. Another example, NSS can bring in live chemistry/science experiments and present that to the children. This is an opportunity to discuss all the ways we can collaborate.
- # Jim Goodrich: One of my long term goals is to open up a pilot program for summer, like summer camp at Cal State LA and actually have people from the physical ed. Department or PE teachers in training come over and do activities as well as the arts. I'm working on getting the licensing and getting a classroom over at the gym. Being involved with any department, possibly have a different day for every department.
- # Kenya Pineda: Summer school is a great idea, especially with CCOE students, a lot of us work at schools so when the school year is up we don't have anything to do. So with providing the opportunity for summer employment to get work-experience through the CCOE would be beneficial.
- # If we can work together to make that happen, I would love to see us have a summer specifically for school age kids. There would be multiple programs. We could call it eagle camp at Cal State LA in collaboration with the children center.
- # We want the center to be a hub where all departments are able to be represent.
- # Kenya Pineda: In order for that to happen we need to change the way students are informed about the center.
- # Jim Goodrich: What ways would offer most visibility and be most effective?

- ✦ Candy Noriega: Advertising. I don't see any of that. Sure, you could table, but after that there is no longer a presence.
- ✦ Jim Goodrich: We have a website, but it's at the bottom of the resources page.
- ✦ Kenya Pineda: Do you have any form of social media? Posting artwork, materials or photos of the classroom without the children. That could create some visibility.
- ✦ Jim Goodrich: We have a Facebook page, so even with creating another platform the issue would be getting it out there.
- ✦ Selene Castillo: The key is hashtags.
- ✦ Debbie Ascension: We can have our PR commissioner work with them to help out.
- ✦ Ashley Joseph: Having more things at the center to bring students there can help with visibility.
