### Proposal for adjusting Executive Workflow

**Purpose**: This proposal serves 3 purposes. The first is to better utilize the time of Executives by pulling them out of the committees that aren't necessarily in their areas and have them focus on the committees/areas that they are. That in turn would allow the Executives to focus more on their respective areas. The second purpose is to adjust the Internal Committee requirement for Non-Executive Board of Directors from 1 committee to 2 committees so that the vacancies from removing Executives will still be filled and remove the External Committee requirement for all Exeuctives. **Bylaws**

No Item recommended by ASI Standing Committee can reach the Board of Directors unless it has been reviewed by the Executive Committee. The Executive Committee shall also provide general policy guidelines, and make specific decisions, in place of the entire Board of Directors only when the Board cannot be called together to act on an emergency matter.
