- Food Pantry ASI Funding Proposal \$40,000
- Summary: this funding will help us continue to help students.

Questions:

- Kenya: I know where Food Pantry location is, the location is not the best. Concerned of the visibility.
- David Z: Can you explained a bit more on detailed of \$32,000 for food?
- Presenter: right now, each bag of food can support a student for at least 2 days, and that costs about \$10. We estimate of giving out 100 every week, so it is about \$1,000 per week, for about 16 weeks. Students do come during finals week as well. They also come during non-service day.
- Kenya: Where do you shop at for food?
- Presenter: We tried many different places, dollar store, amazon pantry, smart&final. Some of them we feel it's too expensive.
- Lily: Can you clarify the funding for supplies?
- + Presenter: it is for tabling, marketing use.
- Barbara: how many staff t-shirts are you planning to get?
- Presenter: right now, we have 7 volunteers and 1 intern. It really depends. I would estimate of 15 people.
- Jazmin: how did you get the numbers? Are those estimates?
- Presenter: those are estimates based on what we had before.

Summary: Currently 125 fulltime children enrolled right now. Have student priorities.

The funding is for whole area of the program: supplies, hire additional student staffs.

- Fresenter: average \$12 in average.

2018-19 VRC Funding Proposal - \$ 12,000

Summary: host several workshop throughout the year (advising, free printing, career, computer room).

\$10,000 for financial needs (main request); \$2,000 for support resources, like coffee, snacks (to create welcome spaces).

- Presenter: We have a committee to select these veteran: Academic excellence based on grading system.

 - Kenya: Please be consistent (when allocate funding).
 - David: I've noticed a lot of these student organizations request funds to pay for their staffs, it is pretty high for students.
 - Lovid: it seems the food pantry request wants ASI to cover the whole amounts.
 - 4 Jazmin: The proposal from EPIC, the amount is too much.
 - Lily: What is the history of ASI funding student salaries?
 - A Neyda: EOP, they are trying to cut that funding, that funding is at risk.
 - 4 I personally would suggest to support this one. Otherwise, that's going to cut student jobs.
 - Dena: over the summer, two students were hired at front desk, it was from EPIC, EPIC program provides real life working experiences.
 - Aaron: BOD decides to not giving funding to U-PASS in the future.
 - Aaron: The board can overturn that decision.
 - David: I remember the letter says, "ASI won't be able to fund unless they are going to reduce the costs".
 - Harcos: I do not think we should fund for the U-PASS.
