# **Vice President for Academic Governance Committee Report**

#### **Academic Senate:**

The Public Records Act and the Legal office gave a presentation on the privacy of emails and technology used for school information. There has been a drastic increase of spam and viruses in emails on all 23 CSU campuses. They also emphasized that any information received through personal emails or accounts (other than calstatela) then becomes the university's property and can be asked for. Fortunately, the motion for early registration for notetakers has passed. Furthermore, tenure track and lecturers should be carefully chosen so that they have will have greater impact at Cal State LA with plans to help the success of our students. There have been thirty-four successful tenure track searches filled in this past academic year. The 2018-2019 academic year goals will be to acquire permanent growth funding versus one-time grant funding to the university. 4,000 of our students do no receive any form of financial assitance and the university will work to change the number by receiving more funds for the university and giving grants to these students. The 2018 school year had big challenges from the enrollment growth seeing that enrollment exceeded state funds. There was a major discussion of reevaluating the admittance of applicants since the university is heavily impacted. The CSU system is working to reevaluate the line of where local students can apply because students are only being sent over to Cal State LA, Dominguez Hills and Long Beach; which, are all experiencing impaction. https://asicalstatela.org/committee/cabinet-academic-senators

# **Educational Policy Committee (EPC):**

The committee drafted some questions to ask UAS regarding the transparency of this department. V. Prabhu also recommended for a panel discussion, a question/answer from the Department of UAS to answer any questions regarding funding concerns and other policies. The committee agreed and will begin drafting a set of questions for this discussion regarding the P.O process, donation funds, and other funds received by UAS. The Administration and Finance division questions were drafted regarding how their budget is being used and who donation and funds are given to. The committee continues to work on drafting the final set of questions. Lastly, FiPC discussed the type of financial information that will be given at the college level committees and whether or not they should be kept private or should be shared with fiscal policy committee members as it will be brought up in university wide committee meetings.
