## PETITION TO REMOVE CAL STATE LA CAMPUS OFFICIALS

We, the undersigned, Cal State LA students, have lost confidence in the campus leadership to effectively execute their duties and formally request the removal of William Covino (President), Lynn Mahoney (Provost), and Tom Enders (Vice Provost for Enrollment Services) from their respective offices no later than 04/05/19 for the reasons of but not limited to:

- Failure to respect the concerns and frustrations of students, faculty, staff, and community members regarding the undoubted detrimental effects that impaction will carry, ultimately preventing the university from continuing to serve its intended demographic
- The involvement of Mahoney and Enders in the impaction of Cal State Long Beach and their decision to present it as the sole solution for Cal State LA's over-enrollment issue that was initially created through the negligence of Covino's administration
- Failure to take into consideration the numerous solutions presented by students and faculty that were supported by over 1,000 signatures from community members and would've prevented the unnecessary lock-out of CSU eligible students
- Failure to propose a redrawing of Cal State LA's local service area that is clearly gerrymandered because of the exclusion of South Central, Inglewood and predominantly Black communities, subsequently impacting these students
- Continuous mismanagement of campus resources during President Covino's tenure which has negatively impacted students' welfare and critical campus services including but not limited to Class Enrollment, Financial Aid, Parking, Registration, and Advisement
- President Covino's decision to limit student enrollment for those from lower socioeconomic backgrounds while Governor Newsom is providing \$45M funds CSU-wide to rush students to graduate through the Graduation Initiative 2025 while only allocating less than five percent for basic student needs
- Absolute disregard for Shared Governance, ignoring the concerns of the campus community in regards to the devastating effects of impaction, and creating a hostile and retaliatory environment that has intimidated many non-tenure faculty/staff and student organizations
- President Covino received a vote of no confidence in 2016 for his decision to disregard Shared Governance, mismanagement of campus resources, retaliation against student leaders, etc

If the above named Cal State LA officials are not removed from their respective offices by 04/05/19, we request a campus wide election on 04/10/19 offering the students the opportunity to vote on a ballot measure for the removal of the above stated Cal State LA officials. We request the deliberation and adoption of a resolution by the Cal State LA Associated Students Inc and the Cal State LA Academic Senate in support of this petition no later than 03/29/19. We request the California State Auditor's office to conduct a rigorous audit of Cal State LA for the duration of the President Covino's tenure at Cal State LA but not limited to.
