#### IV. Special Presentation:

A. (4:00-4:30 p.m.) - The Role of the University President's Designee - Dean of Students Dr. Jen Miller

- Dr.Jen Miller: This is Cal State A lieel like folk misunderstands that I have two roles within this community. My main role is Dean of students but that is different because I'm also the designee of the president. Which means I'm for ASI I'm going to talk about how they are not conflicting and also use this as an advantage. This is the <u>President cabinet</u>... this <u>group counts on me. I assist with the Dean of Student; I'm a person who</u> advocates for the students and lalso advocate for administration. Myth or fact, the university President tells the designee what to say. (*The audience says Myth.*) Every year someone always thinks this is true. One person thought I had an earpiece. When people are excited or frustrated they think I'm the president. I do have my own opinion and I have my own thought and I'm very careful. I don't speak on behave of the president unless I'm absolutely sure about something. The designee strategies with ASI on key student issues. It's a fact I'd like to see, but this is my fourth year here is Cal State LA, sitting here with you at my beginning and my end. I wished we did this more, think it's a great opportunity. The designee is asked to push agenda. (The audience says Myth.) It's a myth, I get it. I understand that I have my own opinion but here you have to consider other opinions. But again, no one comes to me to say Jen this is your opinion this is what you're supposed to say. We are not from the television, we are here to serve the students. Yes, the university president work with Aaron and I don't know if you have set up the meeting with the president yet but think it's important to have the connection...I focus on being here and if someone has a crisis in the hallway I have to check on you. I'm caring for you and offer you resource afterward... I have a great team that has a connection to resources and again I follow the lead of the students. (Jen Miller talks more the importance of having a great relationship. She talks more about what is her role.) A lot of times we work together with collaborations. If I can be any help with you come talk to me, I can help. What are you looking
- David San: From what I got is that you bring back information from the President and administration to us. Partnering with other departments.

- ➤ Dr.Jen Miller: I'm glad that you mention that because not a lot of people know that. I work with the Marking team to work with anything that need to be edited and get it out. Other departments does not have assistance sending email to students we are very cautious when we send things to students. For instance spirit week, we don't approve much for other departments but for ASI we approve multiple emails...

#### V. Reports:

- A. ASI President: Aaron Castaneda:
  - Aaron Castaneda: One of the things we are working on is recruitment... We have a long way to go, we are doing our best we can in recruiting. We are trying to fill in these positon with the best we can so that we can prepare ourselves for the summer retreat. Thead out to the CSSA which was at CSU Monterey Bay. Every June is a training for the upcoming board and we have brand new faces... After that, I had the opportunity to go to the seminar at the Monterey Bay. I had the opportunity to work with other student body presidents and I found different unique ways of leadership. It was a long day, it was six days and it was classes and I have homework every day so I did get credit for it. I did it because it opened up different perspective... Finally, some of you might have seen it but there was an audit that came out of the state of office. The title of the audit (Aaron mention the title of the audit) which I encourage you all to see it. I had the opportunity to read and I must say it's disappointing... In the coming days I'm going to release an official statement regarding my disappointment in the report and what CSULA is doing. If you want to know where the information is at please look at our website. Our next up on report is Christopher Koo. I know some of you have meet with him but he is unable to be here for the entire summer because he is doing an internship in Washington.
- B. ASI Vice President for Finance:

- C. ASI Vice President for Academic Governance:
  - Jacquelyn Acosta: One of the biggest thing I am preparing for is the academic senators training which will happen in July 3. Marcus knows this training is important to me because my area is very impactful with dealing with the University policy which has a lot of influence. This will show them what my expectations are and really inform them of how to interact with the administrators and to really bring students voice. I do have a lot of materials and I'm doing a lot of editing right now and creating my own policy which states what my goals are for the upcoming year... My positon deals with university affairs, faculty, and administrators. From my experience, I realized how there is a lack of support in my area. (Jacquelyn Acosta is voicing the importance of having the faculty and administrator support in her area.) Seeing from last year, I'm shifting my experience and focus in a different area of my expectation and what I want them to bring to the table when they collaborate with ASI. One of the things we struggle last year is transparency and it's an ongoing issues that we have in ASI. (Jacquelyn Acosta is voicing that other campuses had issues with tackling transparency within their ASI.) One of the things we also mention was podcasting because a lot of student are listening to podcasting now to updating information.
- D. ASI Vice President for External Affairs and Advancement:
  - Joceline Rivera Jimenez: I have my expectations and I understand that other people have their own expectations which I want to start adapting to them. I'm also trying to get more ideas of other events so that we have more students engage and let them know what is going on in ASI. Letting them know about policy that can potentially affect them and CSULA as well.

- Pandian Rajaram: I'm working on an idea that I learned from Joel. I realized that when we have an event we would have food for 50 people and only five people would show up. We have food but people don't come to eat and I know on campus we have food insecurity. I noticed that we have people coming to our office saying if there was any event with free food and I'm trying to find a connection. I came up with an idea such as making an app that shows events that are happing on our campus. So, basically I'm trying to push students towards there to eat which can help the attendance of the event. I'm working with my best friend in this project. My next project is an old event. I'm working with a Civic engagement in this project...
- Pandian Rajaram: Two months... It's easy for me. Next thing is updating. I might need help to push it and let people know.

Joceline Rivera Jimenez: How long is the app?

- > Student: For the student who said where the free food are have you told them about the food pantry?
- Pandian Rajaram: Yes, they know but most of them would come on Wednesday. They want like easier access.
- > Jorge Salazar: I want to make an announcement that I was selected as a student delegate of Hispanic association.

#### E. ASI Secretary/ Treasurer: David San

For me is potentially paperwork and stuff. So I have sent out the Bi-weekly schedule for the summer. I will be making another one for the Fall as you can see that the graphic team had put up. For the GIA, I want to make sure you guys know when the Bi-weekly are due. Some other things that I'm working on is looking through the policy and making sure everything is up to date. I'm looking towards more in my area because it was lacking to meet quorum last year. The other thing is how Joel mention such as having smaller events. I want that in my area where we have low cost no cost, events for ASI. I think that me working more with VP Finance and making sure we have spaces to do that event.

#### F. ASI Board of Directors:

- Nadine Gostantian have a question, so I know we are a public University. We have people coming here and ask for and ask us for donation. So, I work in the ITS and one of my friend said a lady asked her for donation and she followed her in to the Library and she would follow her around. Do we have a certain area for them to just be at? (Nadine Gostantian speaking on experience of having a spot for people who ask for donation on campus in her old campus.)
- Dr. Jennifer Miller: We'll talk more about the specific. All around our campus is a free public speak zone. We do have an open forum area where people need permission but free speech is everywhere. Following people for money is not free speech. I want to know a little bit more... If someone is feeling unsafe let me know so we can start making calls. People who table on our campus needs to reservation... Your classroom is where you should learn not where people should be asking for money. This concern me a little bit so please let me know more

#### G. ASI Staff: Marcus Rodriguez, Interim Executive Director

- Marcus Rodriguez: We have a couple of audits going on. We have an internal audit from our University auditors. I may bring you some updates when those are finish... (Marcus Rodriguez is speaking about future plan for alternative break.) This is a great time to bring the new leadership risk management in helping up to look at the program as a whole. What transpired us there is our external audit with our new auditors. They requested paperwork from us and there are strict deadline for those. Dena and I have been working with BFS as well as our campus offices...Shout out to Dena for getting all those document ready while transiting into the closing year. We are doing two audits and minimizing our accrual. CSSA is coming together and we have got everyone to pay... Now before everything hit committee we have to make sure relationship is being made with budgets and adjusting the budget accordingly. I have been reaching out to see where new partnership can happen and obviously coming out from a meeting I see a lot of single partnership that is really exciting...Dean Rodriguez had reached out to us for collaboration so I'm going to have a meeting with him soon. We have all these collaborations, so we have to get the ground running so start setting up a meeting with me one on one so that we can get all date schedule for the calendar. We are hiring a production assistance... We are going to have someone who will help us build that information and date... Gus has been talking to Aaron regarding ASI branding... July 8 we'll have a senior coordination coming in to help us.... (Marcus informing the board about the phone app.) Make sure to sign your paperwork so you may receive your GIA.

  - > Dr. Jennifer Miller: It's good to be back, I was gone for a while and I know I've missed a few things... I did schedule a meeting with Aaron to just see what he needs and see what his ideas are. Marcus and I are

back in the game...Joceline and Panda, I'm looking forward to meeting with you to see what connection we have and ideas for the future... I'm looking forward to meet with Jacky to talk about what you need and find a better process for the committees.

> Jacquelyn Acosta: (Jacquelyn Acosta is voicing that she sent out the information to the administrators but no one was responding which prevent her from updating the information with the committees.)

> Dr. Jennifer Miller: I have a couple of ideas and suggestion. The biggest thing with the have on our campus was the measles things. We are looking forward to informing the students to get vaccinated...(Dr. Jen Miller is voicing the importance of having leadership.) We have after hours, I just want to let you know we have those. We also have a lot of donation for the food pantry and we are trying to donate to the housing as will but we need to see with our budget.
