not limited to: menstruating women, some transgender men, intersex individuals,			
and non-binary people who menstruate and need menstrual hygiene products,

availability at the Health Center, and the Cross Cultural Center (CCC) and various pantries in college departments where said availability is solely reliant on donations, *and*

WHEREAS, President Covino and his administration have abandoned standard sharedgovernance practices, refusing numerous requests for discussion forums, and failing to involve the university community in key decisions such as the impaction declaration; and

- WHEREAS, Cal State LA, an institution of leaders who strive for inclusivity, in implementing this program, can set an example, similar to those at Brown University, Columbia University, Emory University, Duke University, and others ³, by moving forward to support a more inclusive environment, *and*
- WHEREAS, -California State Legislators have amended Assembly Bill no.10, Section 35292.5 and Section 66026.5 of the education code to add Section 50410 to the Health and Safety Code which would require all K-12 restrooms in public institutions to provide feminine hygiene products and encourage public universities to do the same⁴, andand
- WHEREAS, To put this cost in perspective, if each student who needed tampons at Cal State LA was provided with ten tampons per semester, and each costs an estimated \$0.15 to provide, it would be approximately \$24,360 per semester, and
- THEREFORE BE IT <u>RESOLVED</u>, That the Associated Students, Inc. of Cal State LA, recommends Cal State LA to provide menstrual hygiene products in female and gender neutral restrooms in all facilities campus-wide, *and*
- **THEREFORE BE IT <u>RESOLVED</u>**, The ASI Board of Directors recommends that Cal State LA provide a suitable quantity of feminine hygiene products to sufficiently support the need to students using restroom in facilities campus-wide, *and*
- **THEREFORE BE IT <u>RESOLVED</u>**, ASI recommends that Cal State LA provide menstrual hygiene products free of cost to students in facilities campus-wide, *and*
- **RESOLVED**, that copies of this resolution and supporting documentation be distributed widely, including, but not limited to, the Cal State LA Campus President William A. Covino, Vice President for Student Life Nancy Wada-Mckee, Associate Vice President for Student Life and Dean of Students Jennifer Miller, Vice President for Administration and Finance Lisa Chavez, Associate Vice President For Facilities, Planning, Design and Construction Barbara Queen.
