# State briefly why are you are applying and/or are interested in this position

I was interested because I would like the student government to collaborate with departments (such as those that are part of the College of Ethnic Studies-PAS, CLS, and AAAS) or community organizations to put on workshops to push for social justice on and off-campus. Additionally, I would hope that putting on some sort of event(forum? town hall? a day-long conference?) to allow for students to engage in conversations on where the university falls short on addressing social issues. Engaging with the student body to gather ideas can lead to pushing and demanding more from the university administrators to not only say that they support the BIPOC students but to also act on the words that they say.

#### What do you feel are some of the major problems facing the students of Cal State LA?

There isn't sufficient resources for students of color/first-generation students on our campus. The administration seeks to push initiatives wanting students to graduate within four years, yet there is no system in place to ensure that classes students need, when they need it (not just every other year or one semester each year) which results in them having to stay longer and also pay more money. There have been students to spoke out about professors that have made students feel belittled as a student of color, yet these professors (whether they are tenured or not) are not held accountable.
