This new political view is different and will help me learn about other things that are not in my major.

#### What do you feel are some of the major problems facing the students of Cal State LA?

Some of the major problems that I think that students of CSULA face, right now during the COVID-19 global pandemic, include the lack of access to proper technology, internet access, a peaceful, hygenic study environment, and maybe even the fear of participating in online classes. The most major problem that I see, however, is that many of these students have lost their jobs, due to the pandemic, so now they have to prioritize survival over education. I think that being in this position of associate justice will give me the ability to influence policies to help students.

## List activities and/or organizations that you have been involved with (on or off campus)

I was in the NSS Steering Committee in the spring of 2020 and I learned a lot about the problems that students with majors like mine face and the problems that faculty have among themselves. I also learned a lot about how policies play a part in departments such as this one, with majors under NSS being really popular with students.
