If Cal State LA were to do this, our college would be a pioneer in sustainability and be able to self sustain in so many ways with out relying on fossil fuels as well as actually being zero waste. The university could use the campuses trash to power the school's electricity needs, the bio-fuel could be used at a pump at the hydrogen station on campus, we could use the fertilizer for the edible garden and plant more trees on campus, and other useful chemicals could be self sustaining in laboratory classes. There is even more to discover about this green technology and so much research can be done on it to discover its possibilities. I'm sure it's a long shot and expensive but this could change the university and spark a green revolution on campuses across the country.
