Another issue is the CAPS system. There are not enough counselors to attend to the school's population. They are a very valuable resource that unfortunately is not adequately available.

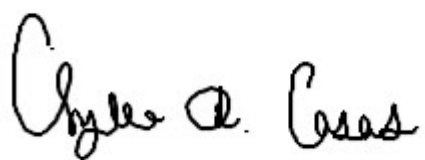
**Family Educational Rights and Privacy Act of 1974**
