- 3. Abel asked if the experiences would be a virtual or physical experience. Example would be the Food and Toy drive
 - a. Jennifer said that there won't be anything on campus. They did reach out for donations without physical gatherings to sort items. Probably will know more in a little bit
 - b. Kayla said she is collecting questions to bring up for an upcoming meeting.

iii. Dreamer's Resource Center

- 1. Serves undocumented students and creates a safe environment for them
- 2. Many different outreach programs
- 3. Funds scholarships, gatherings, and meetings that the Dreamer center.
- 4. Ledi added that she thinks they are still providing services like workshops and legal.

iv. Food Pantry

- Jennifer updated that there will be funding to do food bags for this semester for food. Also food plans food for housing. Making plans for picking up food and donating money to order food for students. Funds will also help for Spring if possible.
- 2. Ledi asked how much ASI would usually fund the food pantry.
 - Jennifer said that they budgeted for what ASI already allocated and whatever extra would go towards Spring
 - b. Ledi said that she thinks that the amount should be increased since it is a resource students use.

- c. Jennifer said that she doesn't want to put pressure on increasing funding because they've already planned for the allocated amount and want to see how it will do first.
- d. Analiz asked about the hot meals program.
- e. Jennifer said that for now it will only be for current students in housing.
- f. Analiz asked about ASI starting an emergency grant for food
- g. Jennifer said that for now it will only be for Housing students to keep people safe.
- h. John asked about the emergency grants program
- i. Jennifer explained the different grants and where the money came from.
- j. John asked how many students were in housing
- k. Jennifer said that there are 66 students and they have to prove that they have nowhere else to go.
- 3. Abel asked why the food pantry had a decrease in funding for this year compared to last year.
 - a. Dena answered because they overspent on a previous year their allocation was brought down to account for that.
 - b. Abel said that he feels that that number should be increased for students.
 - c. John said that we also need to consider how students would pick up the food.
 - d. Kayla mentioned that before talking about amounts, she would like to talk to organizers first for more information about how much they would need.
- v. ECST Acceleration Initiatives
 - 1. Summer program for high school students to get started on their careers
 - 2. This summer was to increase the number of female students in STEM. ASI funded to help the program with technical resources and the students assistants who helped.

3. Kayla mentioned that the program already happened during the summer.

IV. Discussion Items

- a. Future 3&9 Budget Edits: The committee will learn of the possible edits to the budget and discuss further on other areas.
 - i. Kayla went over some of the changes that were made to the 3&9.
 - ii. Kayla asked about the max percentage that could be put into the trailer system
 - 1. Dena said that according to the reserve policy, the max is 25%. The reason why it is being proposed is because the pandemic is going affect the next 3-4 years.
 - 2. Kayla asked what the recommended amount would be.
 - 3. Dena said that it would be dependent on the draft audit. Then options can be proposed that will be voted on. Dena asked John if it could be more than 25%
 - 4. John said that it is up to the committee if that threshold is needed or if its more of a one-time change. More of a discussion on what the appropriate direction would be. Not a straightforward answer.
 - iii. Kayla said that for travel it will be heavily cut since the only costs will be for registration
 - iv. Fee for legal services might need to be increased for any future litigation
 - Ledi said that if it is against ASI then it would be us. But if it
 was a university the university has a legal counsel. Ledi asked
 Jennifer if the university would help.
 - 2. Jennifer said that yes, no, maybe. It depends on the lawsuit since its based on all the fees associated, which would be a combination of things
 - 3. Ledi said that to mitigate risks, we should allocate more just to protect ourselves.
 - v. Kayla said that alternative break would be cut which is one of the biggest things from the travel budget

- vi. Savings in development and trainings since it was all done virtually
- vii. Change GIAs for student members because there will be a full board of student leaders
- viii. All 20 book vouchers for the semester have been sent out, but not sure if they have been used yet
 - 1. Can add more for the Spring semester if needed
- ix. \$55,000 for student clubs and organizations might be raised to \$60,000 to still support students during this time to still keep on community on campus
- x. Programming and advocacy will remain the same.
- xi. Some areas were backfilled like marketing.
 - Ledi said that Gus might need more budgeting for upgrading technology to do transcriptions or add-ons on the website.
- xii. Kayla asked if anyone had ideas to help support students
 - 1. Diana asked about funding students to utilize CAPs for the fees during the summer.
 - a. Jennifer asked if it would be help specifically for the fee
 - b. Kayla wanted to clarify about the summer date that Diana mentioned
 - c. Diana said that its something to look into next summer for students who can't afford CAPs during the semester.
 - 2. Abel asked if ASI Funded CAPs
 - Jennifer said that they are funded by the fees they collect
 - b. John asked if the Student Health Center was still open
 - c. Jennifer answered that they are doing telehealth and stress workshops
 - d. Abel added how ASI could help support CAPs
 - e. Diana said that she will email able with all the information.
