III. Reports: (3 Minutes each)

a. Vice President for Academic Governance:

Jocelyn Vargas: Jocelyn gave updates regarding the Town Halls for February 16 and February 18 and promoting the events. This included reaching out to the Graduate Resource Center to distribute the marketing materials for mass distribution to students at large. Jocelyn also went over how to obtain feedback from students and how to deliver that feedback and concerns to the Academic Senate every week. She also discussed the potential of creating a preferred name-change policy.

b. Academic Senators:

- i. Jeovana Lopez: Jeovana discussed conversations in AIRS related to CurricuLog and inconsistencies in course and program proposals. She stated that this prompted the creation of a Google Doc where people could list their complaints. Jeovana discussed the conversations in EPC related to feedback from the Academic Senate related to policies as well as current discussions in the EDI taskforce.
- **ii. Kinsley Wang:** Fiscal committee did not meet. University Appeals Board did receive appeals requests from students and continued to meet with professors on her own time within the College of Business and Economics.
- **iii. Anson Noland**: Anson discussed Student Policy Committee and academic dishonesty as well as a time-certain with Carol Roberts Corb as well as concerns that each department has in relation to academic dishonesty. He discussed the resources students could find in order to steer them way from academic dishonesty, but also how professors could better understand students in order to be more lenient in the ways students are tested.
