What previous experience have you had in the area in which you are applying for?

It may seem old that I am applying for Chief Justice given that this position essentially runs a branch and leads individuals, in this case the Associate Justices. But I believe I have the experience to be the Chief Justice for Cal State La. I transferred from Santa Ana College, and I was heavily involved in Student Government at my respected community college. Within my time in Student Government, I held four respected Leadership positions, but the one that I enjoyed the most was being Chief Justice for Santa Ana College. It was my last year in Santa Ana College that I had planned to run for President of the Student Government. I unfortunately came short of winning the election, but I still wanted to represent the school and give back to it. I knew being Chief Justice was going to be my best option to do so, thus I interviewed for the position. Within my time in Santa Ana College, I first had to build my Judicial Branch as I had no members, I recruited six students to be Associate Justices. After building a solid branch my second goal was to amend the constitution and the bylaws. Amending the constitution was difficult as that had to be approved by the Legislative and Executive Branch and lastly the school had to vote on it via elections. Revising the bylaws was not as difficult as it only had to be approved via various branches in the Student Government. The reason for the revising of the constitution and bylaws was that there were lots of discrepancies within both articles. I believe within my time as Chief Justice I put the Judicial Branch on the radar and made the Judicial Branch well known. Aside from this experience I was also responsible for leading meetings with the Associate Justices and creating agendas and knowing the respected constitution and bylaws well. I enjoyed the position of Chief Justice as much as I liked representing and giving back to the campus of Santa Ana College and hopefully soon Cal State LA.

State briefly why are you are applying and/or are interested in this position

I always felt the need to be more than a student when I stepped foot on my respected campuses. I recall my first day at my community college. I felt drawn to the student government building and thus I applied. However, my first year at Cal State LA I too wanted to apply but wanted to get situated first. I now feel like I am ready to serve and most importantly give back to Cal State LA. I feel like every student should give back to their respected campus and make it and leave it better than when they arrived. Yes, it is a bit hard for one person to make a difference but collectively a positive change can happen. Another reason for wanting to get involved in ASI is that it can serve as a motivation to do better in school. Since ASI has requirements, one could do their best to achieve those requirements and surpass them to stay in the organization. As for why I am interested in the position, learning how the constitution and the bylaws work is interesting. Furthermore, learning the integral structure of the respected branches is necessary for the meetings to run smoothly. I want to reiterate my most important reason for wanting to apply. I want to give back to my school and leave it better than when I entered.

What do you feel are some of the major problems facing the students of Cal State LA?

It is a bit hard to understand and see the problems of Cal State LA when my first year was spent remotely. However, following various social media pages on Instagram I did see one issue that was brought up continuously. That was the issue of graduation or formally known as commencement. Various students were complaining that commencement was not fully being offered to the best experience possible. I believe graduation got postponed to another later date after stating that it was going to take place in the Rose Bowl. So, addressing that issue and allowing it to run smoothly next year will be something to work on. Aside from that another major issue is the requirement of students to be vaccinated to be on campus, that is something that should be addressed extensively and whether we are going to require social distancing guidelines along with the use of facemask, now that California is "open".
