## What previous experience have you had in the area in which you are applying for?

I have served in ASI as an Associate Justice for over a year. In this position, I have been familiarized with parlimentarianism, procedure, and committee leadership- skills that are important for the position of Chief Justice. Additionally, I have been involved extensively with examining, analyzing, and crafting policy and procedure, which would serve me well in the position as the Bylaws and Codes of Procedure chairperson. Finally, I have chaired a hearing in the Chief Justice's absence, familiarizing me with the duties of a chair in general and also with the job of the Judicial Review Committee moving forward.

#### State briefly why are you are applying and/or are interested in this position

I have served in ASI over the course of the past year, and have seen the positive impact the student government can have on the campus, especially in difficult circumstances. I also recognize the importance of being able to keep the government up-to-date and knowledgeable in its policy and procedure. I believe that I will have a chance to further both of these objectives as Chief Justice, building on the successes of the previous administration's Bylaws Committee, and continuing the campaigns and ideas from my last term. In short, I believe I can continue to serve ASI well and help the students of CSULA by applying my experience gained in the last term to the position of Chief Justice, and continue to help ASI's policies internally and assist the campus at large.

#### What do you feel are some of the major problems facing the students of Cal State LA?

One of the biggest challenges that must be dealt with is the return to in-person classes over the summer and fall of 2021. Many of the logistical and organizational changes facing CSULA when returning after the pandemic will cause upheaval and disruption in the campus community. This problem will need to be fixed by ASI and its ability to both rally and unite students to come to better ends. Additionally, I believe that ASI's internal policies and procedures may need updating and improving to both serve the organization functionally, and to better reflect the current values of ASI. Seeing as ASI can only serve the students of CSULA well if its own policies and procedures are in order, I believe this should be another priority for the incoming year.

I have served as an ASI Associate Justice for more than a year. This has given me experience on ASI's internal workings and organization. I have also interned with multiple Congressional campaigns in the past year, both leading meetings and teams and crafting campaign literature.
