#### Discussion Items

- > Book Reimbursement Program: The Board will review the Book reimbursement program revision.
  - Barnaby Peake: We are trying to change this process as a reimbursement and the goal is to get more students free books and make the process easier.
  - Amanda Maldonado: The reason we wanted to revise this is because we would give the people who applied three hundred dollars and not everyone that applied would use the entire of the money. We changed some of the criteria which is that you have to be working 20 hours a week and have an evening class and a certain GPA and at least one semester and what we did was eliminate all of them and now you just must be registered full time which will open it up to more students. So now we are offering up to \$150 for reimbursement and a Barnes and noble gift card if you go through the bookstore to support the bookstore. Amanda goes over several other changes made to the book reimbursement program.
  - Meagan Domingo: I feel like a lot of students can benefit from this and we are working on the W9 part because of status of citizenship.
  - Amber Beasley: Is this for undergrad only?
  - Meagan Domingo: It is for everyone.
  - Amber Beasley: I think full time for grad is 8 units right.
  - Cristian Flores: It is technically 6.1 units.
  - Meagan Domingo: Thank you for bringing that to our attention.
  - Cristian Flores: I think that it is good that this is going now to everyone now.
  - Dena Florez: I saw the application deadline and reimbursement there's an adding class deadline would you consider a deadline on this like a week after that date.
  - Meagan Domingo: I think we would have to put the deadline when you must start doing W's because a lot of people are adding and changing classes a lot so because they have to submit their syllabus, they would have time to do something like that.
  - Sydney Lim: Approximately how soon do the students get reimbursed?
  - Amanda Maldonado: It takes about one to two weeks, and it depends how fast everything is turned in and the signature process and when the checks come in, we call them.
  - Hope Hua: Is there any scaling? Because I have had to buy an access code that was \$120 nonnegotiable, and I know that some of these lower divisions require those access codes and I was wondering if there was that scale?
  - Meagan Domingo: This is something we were all going back and forth about because the amount that was being given was three hundred and Dena said people were not using the whole planning and I am planning on when we start this seeing the average and adjusting it.
  - Hope Hua: Would it be possible for students to petition to get more money? If their textbooks or access codes were way more than they were expecting.
  - Meagan Doming: I think we are having one more meeting about this I'm sure we can talk about it.
  - Barnaby Peake: Just as a quick reminder there are twelve thousand that is allocated to this program, and we are dividing six thousand for fall and six thousand for spring and that is what we are looking at and as Meagan said we are doing data analysis and that is where we are setting this new limit and if more do come in we can look at this again.
  - Cristian Flores: I know before we were thinking of reducing it and having a surplus and if students are taking advantage now then I think we should reexamine the fiscal budget for the next year that is being proposed.
  - Dena Florez: We can definitely look at the budget and then increase it.
  - Diana Chavez: We are going to vote on it but if we are doing the unit revision we just need to motion and is possible.
  - Barnaby Peake: We don't have to take action but if there are recommendation give that to us now so we can incorporate it.
  - Cristian Flores: I think just saying full time status for respective classification I think is sufficient.
