Club/organization and event information by a representative.

- 1. Giovanni Castellanos the club's Treasurer, presented ASME's Funding Request Packet
 - a. We are requesting ...our request is for the event, Mechanical Team Workshop, where we are going to be going over important concepts in robotics. So, with that, the parts we are requesting fall into the list of power supply, gears, transmitting wires, signal, mother boards, and square tubing for the film. With that said this meeting will be online through Zoom. It is open to all Cal State LA students as long as they're interested in robotics. We plan to have an expectancy 15 people. If you have any questions about the workshop, please feel free to ask.

Committee Questions/Discussion:

- 1. Josue wanted to confirm that none of the items were already purchased
 - a. Giovanni said, "No, they were not already purchased."
- 2. Josue added a second inquiry, about when ASME is done building the robotics if they keep it together or do they disassemble it, reuse the parts, and how does all that work?
 - a. Giovanni stated that they disassemble it and reuse the parts for future workshops. For example, they plan to reuse some of the parts from last time into this new build. We test the parts and if they are still running good then they will reuse them again for the next workshop. But if not then they will request for new ones again for future workshops.
- B. Daniel Gonzalez thinks ASME's organization came to ASI in the Fall semester and requested funding at that time as well. Daniel is asking ASME is they have an example of their finished product that they did.
 - a. Giovanni stated that they actually submitted a picture with the RPP packet (from last Fall's approval)
 - b. Amanda Maldonado confirmed the receival of this submission as well.
- 4. Dena is inquiring to Giovanni that they mentioned that the total expected attendance is 15 and this is open to *all* Cal State LA students? How does ASME market this and how do you promote this event?
