- 1. Ashley Tran (Executive Officer) presented Association for Computing Machinery's Funding Request Packet
 - a. Ashley states that ACM is the Largest science computer club inclusive of all majors. What makes them special is that they are a hybrid organization meaning they offer both project workshops and professional development.
 - b. Interested in securing funding to provide a more engaging and stimulating environment and experience for the club.
 - c. States that all events are open to all Cal State LA students.
 - d. Not going to have the event listed at line item "g" as the funding request is currently being refunded with the Campus Administrator. Will not be approved for this week's funding meeting.
 - e. Ashley went through each description of funding events listed a. k. via funding request forms and event flyers, not including line "g".
 - f. (Descriptions are in further detail under the individual motions A. K. listed below).

Committee Questions/Discussion:

- 1. Josue wanted to verify information for Game Night #1 seeing there is #2 listed and not a #1.
 - a. Ashley confirmed the event would have already happened thus not having enough time for approval.
- 2. Veejay added an inquiry of how the gift cards for certain events will be "distributed" at random; will this be online or an in-person disbursal?
 - a. Ashley states that she believes it will be disbursed via email.
- 3. Veejay also added an inquiry about the Virtual Conference to confirm that it is indeed fully online, and no travel is needed.
 - a. Ashley confirmed that this information is correct
- 4. Veejay inquired about the Movie Nights. Since it is an in-person component, to ensure that ACM is checking with all the event members to use the Presence check-in app for utilized contact tracing and to make sure the club has all the information. Only for members of the organization and not for non-Cal State students.

- a. Ashley confirmed that the Treasurer is aware of this and has the needed information.
- 5. Daniel inquired about the number of attendees expected (due to COVID) to be present at the upcoming events and the accuracy of forecasted attendees. Daniel also wanted to know overall active members.
 - a. Ashley stated that roughly they can expect the total of 44 people for the first Movie Night and then 45 for the second Movie Night event.
 - b. Also, Ashley confirmed there were 80-90 current active members, and this was also based upon a recent sweep on discord to properly calculate active members.
- 6. Rebeca was curious if the event was open to the general public of CAL State LA students or if it is just exclusive for ACM. Also, Rebecca was inquiring how the tickets will be disbursed since there a limited number of vouchers.
 - a. Ashley states that there are assigned leaders in the club to sell at least 2 tickets which are logged to keep track of progress.


