**a. Presentation from Dr. Bell – TPM Policy**

Megan Bell goes over the Time Place and Manner policy- a tool to help us preserve and uphold free speech, unique mission to uphold these values. Chancellor wrote this policy in the summer; we need to identify these policies system wide (new that governs the CSU policy). Cal State LA updated an addendum. There is a video on free speech and college students, as a public university we have to uphold the policy as there are very few laws to what is protected speech.

Four areas of protected speech- true threats, harassment, unlawful conduct- vandalism, destruction of property disruption of events, Incitement-encouraging immediate lawlessness. In what specific ways does ASI uphold the value of free speech and expression?

TMP Three types of Space - System Wide

1. Public Areas (public forum) U-SU plaza and main walkway to the eagle statue what is tricky people do reserve the plaza.
2. Limited Public area all other exterior outside space on campus.
3. Non-Public Areas- all the interior on campus including library and U-SU.

Key Points- can't be a free for all and not far reaching.

VP Patrick Day is Cal State LA's Designated University Official for TPM, and a Campus response team is now in place. (see the addendum for the full list of members on the response team)

The policy prevents camping/lodging or building of temporary structures. Prevents disruption/shouting down of scheduled events, classes and activities. "Hecklers Veto" Masks cannot be used for the purposes of evasion or illegal activity. Must provide ID when asked during official campus hours. Viewpoint on content neutrality. Have to enact the policy despite personal beliefs. Campus administrators cannot take a political position or use any Cal State LA resources (money, time, and social media) to support political candidates or issues. Student employees are free to express themselves, gather, demonstrate as long as they not on the clock and speaking for Cal State LA.
