

1 **Resolution of the Cal State LA Academic Senate: Reaffirmation of Values**

2 **Whereas**, the University-wide Guiding Principles of Equity, Diversity, Inclusion, and Belonging
3 at Cal State reflect the identity of the University in its commitment to these core values; and

4 **Whereas**, academic freedom is essential to the mission of higher education and ensures the
5 ability of faculty to teach, research, and engage in public discourse without undue restriction or
6 interference; and

7 **Whereas**, this freedom extends to all matters pertaining to Equity, Diversity, Inclusion, and
8 Belonging, including Critical Race Theory, Gender Theory, Queer Theory, Disability Theory,
9 and any other theories that address inequities of marginalized groups; and

10 **Whereas**, the Trump Administration has made clear through Executive Orders its intention to
11 demolish all diversity, equity, and inclusion efforts, prevent the teaching of Critical Race Theory
12 and Gender Theory, deport or imprison undocumented immigrants, and erase trans people from
13 civil and social life; and

14 **Therefore, be it resolved that**, the Cal State LA Academic Senate formally re-affirm its
15 commitment to these Guiding Principles that inform institutional decision-making, policies, and
16 practices; and

17 **Be it further resolved that**, the Cal State LA Academic Senate urges the prioritization of
18 diversity, equity, inclusion, and belonging (DEIB) initiatives (including ongoing education and
19 training) and calls for the transparent and equitable distribution of University resources,
20 including budget allocations, to ensure the sustainability and effectiveness of DEIB efforts and
21 social justice programs, reaffirming the University’s commitment to fostering an inclusive and
22 just environment for all; and

23 **Be it further resolved that**, the Cal State LA Academic Senate reaffirms its unequivocal
24 support for the rights and well-being of LGBTQ+ individuals, most notably, in these times,
25 transgender students, faculty, and staff, and calls upon the campus administration to expressly
26 affirm this commitment as well and to strengthen protections, resources, and representation for
27 these communities, including restoring full funding from the President’s Office to the
28 Presidentially Chartered Center for the Study of Genders and Sexualities and providing gender
29 neutral bathrooms that are accessible; and

30 **Be it further resolved that**, the Cal State LA Academic Senate stands in solidarity with
31 undocumented students, faculty, and staff, advocating for equitable access to education,
32 employment opportunities, and institutional support regardless of immigration status and calls

33 upon the campus administration to protect resources for undocumented individuals, such as the
34 Erika J. Glazer Family Dreamers Resource Center; and

35 **Be it further resolved that,** the Cal State LA Academic Senate reaffirms its unequivocal
36 support for academic freedom, including the freedom to teach, research, and engage in public
37 discourse about all matters pertaining to DEIB, including race, ethnicity, gender, gender identity,
38 sexual/affectual orientation, class, and disability using any theories deemed appropriate,
39 including any that happen to be deemed inappropriate by the Trump Administration; and

40 **Be it further resolved that,** the Cal State LA Academic Senate reaffirms its unequivocal
41 support for the College of Ethnic Studies and the Department of Women, Gender, and Sexuality
42 Studies specifically and calls upon the campus administration to do so expressly as well.
