Gabriel: Mentioned he met with the Director of Parking and Transportation about a program that Metro has where they will pay half of a student's pass, and the university will pay the other half; further conversation will be had

III. Informational Items

A. CSUnity & CSSA Update

Arwa: Explained what California State Student Association (CSSA) is - in summary it is where all 22 CSU campuses Associated Students come together and talk about system-wide concerns/issues. Each month there is a plenary (alternating between virtual and in-person). Additionally, explained what CSUnity is - in summary each campus sends a delegation of student leaders, and it gives all CSU student leaders an opportunity to come together, foster discussions, and gain leadership skills (workshops).

Arwa: Mentioned that Virginia stepped down from the Vice President for External Affairs role to pursue an internship. Kanishq has also stepped down from the College of ECST rep role as he obtained a job.

C. ASI Inauguration

Arwa: Explained what the inauguration program is and gauged if the tentative date and time would work with everyone's schedule

IV. Action Items

A. Appointments to ASI Standing Committees

Arwa: Explained this action item is if anyone wants to swap committees if it works better with their time/schedule **Amanda:** Shared the meetings and times of the leaders that stepped down if anyone would like to swap.

V. Discussion Items

A. Financial Aid Concerns

Jeff: Shared that Financial Aid has announced that graduate students will not be receiving State University Grant (SUG) funding for the 2025-2026 academic year. This is especially concerning, as SUG often covers a major portion of costs for graduate students. With little communication from the university and the semester approaching, he reached out to Financial Aid Directors and Coordinators to get more information and push for clearer updates. He received a response from Linda Lopez, Director of Financial Aid and Scholarships, explaining that SUG is a CSU systemwide program funded by the state. Each campus is allocated a set amount of funding, and the CSU prioritizes undergraduates first, followed by credential, and then graduate students. While this has been a long-standing policy, current guidance has reinforced the focus on undergraduates, especially due to a 40% funding cut from last year. To ensure students are informed, Erick and Arwa will be creating a video to share information and resources available. The goal of the video is not to take accountability, but rather to make sure students understand the situation and know what support options exist. Additionally, he shared his own struggles with this funding cut and is committed to staying strong in advocacy. He will continue seeking additional support options for affected students and working with other CSU campuses and their ASIs to understand how they are addressing this issue.

Arwa: Agrees and will speak with Erick on making the video.

B. Meal Share and Food Recovery Proposal

Arwa: Shared that she created a proposal for a Meal Share and Food Recovery Initiative that she hopes to bring to Cal State LA. The goal of the program is to combat student hunger by using existing resources—specifically unused meal swipes and recovered food—that would otherwise go to waste. She highlights that this program is not new to CSU campuses and has already been successfully implemented elsewhere, making it both realistic and impactful for Cal State LA. The primary cost involved would be integrating the meal swipe system with students' One Cards, which would require IT or One Card programming. However, overall, the program is low-cost and has a high impact. Estimated startup costs range from \$900-\$1,700, with most costs being one-time or per semester for outreach materials, training, and marketing. Arwa emphasizes how this initiative aligns with Cal State LA's values of community, service, and sustainability. It would also strengthen student-administration partnerships and foster a culture of care on campus. She has already met with Blanca, who is looking into it further, and Arwa is now seeking feedback and agreement from the Board to move forward with planning and implementation.

Yarmil: Asked on the program, and shares food places on campus where students can access this.

Arwa: Answered and agreed with places she has mentioned.

VI. Reports

A. ASI President

Arwa shared two projects she's hoping to get going on at Cal State LA. The first is the Meal Share & Food Recovery Program. She's also working on Eagle Connect, where ASI reps would be placed with student orgs and wants to group them by type like social Greek orgs, academic clubs, service orgs, etc. to better understand who they are and how to support them. The goal is to get that piloted by spring, and she's hoping to move both projects forward with everyone's input.

B. ASI Chief of Staff

Gabriel shared that he's conducting all ECST interviews today and asked if anyone knows a student who's interested in applying, they should let him know so he can stay in the loop.

C. ASI Vice President for Community Engagement

D. ASI Vice President for Finance

Erick shared that in his new role as a student leader, one of his main goals is to closely review the budget and how student fees are being used. He's considering the possibility of raising student fees in the future but wants to approach it thoughtfully and transparently. His priority is making sure he fully understands the numbers and can clearly explain them to students. If a fee increase were to happen, he wants students to know exactly what they'd be getting in return and how that extra money would directly benefit them. This is a long-term goal for him, and he's focused on making sure it's done the right way, with student needs and trust at the center.

E. ASI Vice President for University Affairs

Jeffry emphasized that he really wants students to see ASI as a space where their voices matter. He hopes students feel encouraged to share their concerns and issues so ASI can bring awareness to them and use that feedback to advocate and take action on their behalf.

G. Reps at Large

Gennesis talked about how important it is to create strategies that really connection with students, building on what Jeffry and Arwa were saying. She thinks being transparent with students and letting them know what is going on is key. Plus, having one-on-one conversations helps build trust and makes students feel heard. She agrees with Jeffry that this kind of personal connection is super important and fits exactly with what ASI is all about.
