#### C. Initial Discussion on Council Goals & Activities for Academic Year 2025-2026

**Jeffry:** Stated the committee will review and research on policies affecting students of Ca State La. The intention of the committee is to welcome university committees at large. They also want to work with all appropriate areas to ensure the principals of shared government are being upheld. ASI plays a role in shared government to ensure students have opportunity to take part in decisions made on campus. One of the main purposes is to figure out where students are needed and where campus administrators view as high priority. They will also go over current students' concerns on campus or living on campus. Discussed with Barnaby about shared government and how it could be improved as they initially experienced some challenges. Discussed academic life on campus.

**Arwa:** Talked about shared government and she does not think about academic life instead she thinks about academic affairs. Believes it should be more focused on academic affairs as it is something she believes in lacking in ASI.

**Jeffry:** Stated that he wants to make sure that students are taking part in share government that is a responsibility of every committee. All university appointments have to participate in shared government. Discussed with Barnaby that the meetings are open to non-ASI members. Discussed with Arwa about developing a different form of accountability to track the activity of students in committees who are not ASI members. It is being decided on the removal of some of the board members.

**Arwa:** Stated that other universities require google form from anyone sitting on university wide committee to report the main points of their meetings.

**Jeffry:** Stated that Barnaby and Dr. Stansberry are non-voting advisors. The chair is in charge of the agenda, meetings, preside over SGC meetings or report SC action, organization, and actives to the board of directors. Wants to provide training and support for members of the council. Does not have a vote unless there is a tie. Vice chair will be appointed to the second meeting Their responsibly is to transcribe committee meeting into minutes and ensure they are delivered to members before the next meeting. The responsibility of all members of the committee is to attend the meetings of the committees they where appointed to, actively identifying issues affecting students, collecting students' opinions, and contacting committee chairs.

**Unidentified member:** Asked the difference action wise between doing something shared government focus vs academic focus.

**Jeffry:** Answered that it is the struggle in which they are trying to figure out this year as they have struggles with this issue in the past as there are some committees that are not really academic focused. Currently there is no body is AS that focuses on the academic life of students. Senators have expressed feelings that they are not representing students to the degree they wish to.

Exploring ways in which senators could be more involved in representing students and their concerns.

**Unidentified member:** Asked if the structure and the name of shared government is going to change.

**Jeffry:** Answered if the focus changes to academic affairs they might shift the name to academic affairs.

**Unidentified member:** Stated the name change could lead to the committee to be caged into only academic affairs. As part of ASI that automatically includes everything not just the academic side. It is a concern that students will think it only relates to academic affairs because of the name.

**Jeffry:** Stated that he agrees and believes they should work on the structure first while keeping the same name then come back to figuring out the name. All SC members must notify if they can attend a shared government meeting or their appointment committee 24 hours in advance. You could also be recommended to be removed for one or more unexcused absences, two or more unexcused absences, or two early departures. Changes toward the amendments could done via voting but it will not go into effect immediately and it will have to be sent up to the board of directors.
