II. Public Forum

- a. This time is allotted to members of the public to address the board.
- Trinidad Castaneda, Student (Gallery): Regarding event on Thursday, 2/25/16. I am going to try and contextualize this in a broader picture of what is going on at Cal State LA and from my perspective as a student as well. A year ago there was an event on "Sex Toys & Us" which was a sex education event mainly geared toward LGBTQ Community. We saw a decision where President Covino cancelled our event unjustifiably. And so as LGBTQ Community came together we rallied and there was an email sent out 15 minutes before the event stating that the Sex Toys & Us event would be back on. And now in February 2016 we have a similar event where a student group put on an event where it was cancelled and later un-cancelled right before it was schedule to occur. I am seeing this as steps to a pattern as something that has to be discussed and thought about very critically as we move forward with the university with the new branding campaign, vision and focus on a sustainable future. So I am coming as a student that has seen both these events cancelled then un-cancelled regarding an issue of freedom of speech for organizers and those who wish to attend the events. Again my concern is that we need to

have leadership that is accountable for these decisions that go back on their word. Those decisions need to made transparent so we can see how the decisions come about.

- Reynaldo, Student (Gallery): I am here because I was one of the organizers that was part of demonstration on Thursday. What I witnessed that day was very poor executive leadership because we were put in hams way. First the event was cancelled and then it was allowed to happen. It left the students vulnerable to a very real threat that I don't think many people understand. But because we are aware of the history, we know it is very true. White supremacist is an all real thing, like the KKK are an all real thing. So when you have threats like people calling you Muslim Negro and telling that same person to expect us on campus and you have people with guns and you have people at the demonstration calling us refugees and bodies are hitting up on you and they were also made a fool on the news. Then you have our President who doesn't show up to the event. That tells me you didn't care. I don't understand what is going on. I am actually shaking right now as there is a lot going on. I don't see the reason for not cancelling this event after receiving all the information because that is hate speech right there. We were left vulnerable and then you don't show up to make sure we are ok.
- Sherry Jones, Student (Gallery): I would also like to add to the event that happened on Thursday, the campus police force did not properly handle the situation as they were not responding to the students that were being assaulted. I feel that they usually follow what the President of the university tells them to do they should have protected the students.
- David, Student (Gallery): I would like to continue off her point. I actually had an experience with campus police they were not acting as proper as they should because originally at the protesting event a lot of the YAF members were being aggressive and pushing the protestors in order to get through to the USU theatre. And me being one of the protesters we had our hands up to demonstrate to the cops that we were not out here to promote violence we were just trying to have a peaceful protest and one of the police officers came to me, looked me in the eye and told me, "I will beat your f---in face if you don't get the f--- out of here. Since then I really don't trust campus police. I expect something to be done about it, because students like me shouldn't be going through this. We should be protected by our police officer, that's why they were called to the scene. I feel this is a matter that should be taken care of.
- Donna, Student (Gallery): For my experience with campus police, I feel there is freedom speech but I don't like hate speeches. But I felt at the same time students were disrespecting. Some of the police officers were nice and they were talking to students. I do feel that there was a lack of respect from both sides. I also feel that both sides could have handled this situation better.
- Student (Gallery): If there is proof that you need about the police officer coming at me, I have a video. The video isn't too clear but you can understand the words that are coming out of his mouth, shouting obscenities at me.

- James Steele: We have student after student saying all that happened last week. I was there and it was out of control. It is not secret that we have had trouble with the administration first with the budget and a variety of other things. At this stage I have a hard time having trust in anything the administration says or does.
- Gregory Bates: It's hard to feel represented at the university. The rally that happened last week was one of the most horrific things I have seen at the university. We have one of the protestors being called racial slurs. I find it hard to believe President Covino has allowed this to happen.
- Samuel Garza: At the beginning of the year it was my understanding that we would have a meeting to discuss the monies owed and my concern was that no meeting was setup. We have been trying to move forward and our budget was frozen. As the Vice President of Administration, I am trying to have great programs in housing and on campus, but I don't even know how much money we have. With the budget frozen it makes my job harder to do. I feel the conversations were pushed aside. I don't feel that is fair to our 27K students.
- Joselyn Diaz: I am not sure if all the students present are aware of what is happening. Sam touched on it a little but our relationship with President Covino has been tense. Since the summer we have been meeting with him, we have been telling him our budget, we have had controversial conversations regarding the Child Care Center. President Covino has issued some insulting comments at some of our meetings. For us it is what happened on Thursday as well as what has happened. Personally I don't know where I stand as far as the confidence vote.
- Sean Weerasinghe: I don't see the legitimacy of this vote of confidence. I feel things could have been worked out if we had handled things properly in the beginning. As for the protest I feel that it could have been handled differently from both sides. From my experience when people protest, it's usually the protestors that aggravate the situation and that is what I was seeing a lot of. I think we could learn a lot from our leaders of the past (Martine Luther King), who actually did non-violent protest. When I see people getting in other people's faces and you have back and forth, things are going to happen. I see legitimate of police force not stepping in because then it would be deemed police brutality if they had used excessive force but I also do see the reason President Covino did cancel the event as there were safety issues and he does have a responsibility to take care of the students. There are a lot of issues going around and I really don't see what this accomplishes.
- Samuel Garza I would like to offer my last comment to students to see if there is anything else they would like to say?
- Student (Gallery) So often students analyze what the media narratives are when it comes to the actions protestors do versus what the invited guests and followers of conservative speakers do. We are seeing allot of the media narratives surrounding this event are directly attacking the actions of the students and we are tired of this. We should feel safe on our own campus! We should not have to worry about white supremacist coming to our campus. We should not have to jump to fear and be paralyzed by a thought of someone coming to campus with a rifle. Regardless if we have the footage or not. We should be moving forward in the 21st century thinking how we can best tackle the larger issues such as climate change, social inequality. But when the media narratives control how people view students it becomes internalized within us and then we start to believe in this crap and we have to stop because the responsibility does not fall on the students to make our voices heard and to provide a safe campus for our own bodies and minds. When we are being mindful of this, then we don't have to resort to this nonsense. As it student it angers me.

- Antonio Canzona: For me this vote is A.S.I. taking a stand. I think it is important. It is the combination of all events that took place last year that is being looked at. Last year when I was the Vice Chair I discovered that UAS owned the Children's center which prompted the initial decrease and then we overturned the budget that was approved by last year's administration, as they gave the money back because they were afraid it wasn't going to get approved. And in an effort to choke us into submission he froze our budget stopping all the processing of payments for employees and everything else. Even our lawyer said that he couldn't do that. I found the executive order that said he can't. When we threatened to go to the Chancellors office, he backed off. We dropped our lawyer and secured the lawyer Chico State used when their budget was frozen. That was an intimidation tactic and from then many of our board members were accused of being to confrontational so Ejmin and I, in an effort to demonstrate good standing we backed off and we created two task forces to help come up with solutions: Budget Priority Task Force and the Children's Center Task force.
- James Steele: We keep saying it's our budget, but it is not our budget.
- Kimberly: I was at one of the meetings that talked about this, but we don't know details about what is happening.
- Joselyn Diaz: Just in case all our meetings are open to the public. Meetings are on our website. There is a group of students that want to see president Covino resign, but others don't. There are lots of things that he has done but need more voice heard.
- Hanz Legaspi: I would like to thank everyone for their attention. Although the real problem is that Shapiro was here spurting hate speech. The root of our problem is social inequality.
- Student: The CSU system is taking a corporate stance at the expense of the students. The people we need to be in solidarity is not admiration.
- Ejmin Hakobian: I got elected to this position and I wanted to make it better. President Covino, regardless of how the vote goes. Please make sure this doesn't happen to anyone next year as A.S.I. president. We didn't ask you to freeze our budget, parking, and or financial aid, but it needs to be done in a proper fashion.
