Removal of Appointed Members Language in Governing Codes of Procedures – The committee will review the language regarding removal of appointed members reflected in each Code of Procedures addressing allowable consecutive unexcused absences, unexcused absences, unexcused tardies, or unexcused early departures during any one (1) semester.

- -Announcing someone as being late, excused tardy announcement during roll call
- -Lack of oversight
- -Absolute limits
- -Room for unexcused and excused absences
- -Three unexcused absences are not acceptable
- -Emergency tardies/absences
- -Defining early departure
- -10 minutes after roll call = tardy
- -Leaving 15 minutes early = early departure
- -2 meetings per semester for monthly meetings
