III. Information Item

e. Policy 004: The Committee will discuss the General Election Committee Codes of Procedures.

Jessal – So, I know we're already in the midst of the Elections but I wanted everyone to take a look at the Elections Policy 004 and provide any feedback.

Steven – I would like to make a motion to amend the Policy 004 to change the Election application period to March 25, 2019 to April 7, 2019.

Jessal - Unfortunately, we cannot do that because that is out of Robert's Rules and we are only allowed to make an amendments at the beginning when we were motioning to approve the agenda.

Steven - Oh, is there any way we can do that now since none of us were aware of how Robert's Rules works?

Marcus – (explains the policies and procedures associated with the Robert's Rules along with the importance of following those guidelines).

Steven - Is it possible to change the Elections timeline now?

Marcus – Unfortunately, no we cannot but if you feel that legal counsel is required so we can go over Policy 004 we can reach out and request a phone call.

Steven - Can we get this done before the Board of Directors meeting Thursday?

Jessal – We can try but it depends on legal counsel's availability. I will make sure to update you with every detail and every returned information I received and put out into the GroupMe.
