#### Public Forum:

- a. This time is allotted to members of the public to address the board.
- Nia Johnson: The agenda today is not the agenda I sent out to Marcus. The agenda has to be posted in the 72 hours in advance. I am going to pass around the agenda that was submitted also please take note the time that was submitted for which was the 72 hours in advance. Unfortunately, that was not taking in consideration. If you look closely it made it as it was called by Aaron Castaneda, Jacquelyn Acosta, and Veronica Garcia-Martinez. (Nia Johnson talks more about the schedule of the agenda). Additionally there was a notification that the meeting was going to be schedule at another time. However, I did not get to meet with Marcus to discuss this because he did not want to meet with me... (Nia Johnson talks about the meeting being postponed). Marcus brought Dena into the meeting because he wasn't comfortable to meet with me one on one. I try to keep personal matters and maintaining my confidentiality as ASI president I wanted to bring these concerns to HR which is the proper procedural. As I tried in the past, Marcus sent out the email to all the executives staff making them raise concerns on my experience. Bringing this to HR I find it unnecessary that it discredit the experience myself and other board members that there is a lack of transparency with an exchange of email with the executive and not with the board. I met with Dr. Nancy that I'll be making this announcement whether in the public forum or through report. Since the report is not in the agenda I am making it here in public forum... Because Marcus is not comfortable with me meeting one on one and because Frangelo was absent I requested that we have to have the administrator to be present with our meeting so that his comfortability will be taken under consideration. There are other things we need to take under consideration. For instance, I do try to meet with people who have a lack of support with staff. But however because I have not been able to meet with the staff one on one I couldn't seek for support. There's also concerns with language and rhetoric that was being used in the office. I like to add and stress that if you are going to congregate in front of the office and make statement in the office please be aware that my office has been and will continue to be open. Please bring your concerns to me and don't openly congregate in the front desk or the next door in your office because the walls are thin. Reason being because I hear racial slur language used from students in the front office. While I am aware that we like to spend time in the office we should consider what language should be used in the office. (Nia Johnson talks more about the racial slur that was heard by the front desk). I would like to make a recommendation that if there's any concern bring it directly to me...I would like to bring up that there was only one ASI member out of the rest brought their concerns to me compared to the rest of the ASI members. I wanted to bring Marcus in to support but however due to the lack support that Marcus felt from Frangelo not being present we have not been there for our one on one meeting. We are looking forward to bring in additional ASI staff support. Also last thing, reference to the Facebook post that was posted and our inability to separate from personal and business. I like to stress that a lot of my term are associated with the action with the man that I dated and not associated with the action so far. So please do not forget that I have been dedicated to empower our student voice and student. If you have any questions about what have been posted by student at large and not me you may meet and speak to the student at large instead of assuming and spreading words.

- Student: In regards to the Facebook post I am the one who made it and posted it. I do believe that we need to vote no confident and now I feel like to we need to impeach the board because look how they acting toward the ASI president...Why they can't come to me like an adult, we are in college, we are all adult. If this is a type of leadership you all want they can't even come to me as students. They are students, you all are students and they can't come to me with the problem they got to come to her. You all got to bash her, you all got to make her name look bad in front of the office saying that because a black women is in charge the office is as bad as it is. That's what I hear other students are saying that ASI students are saying. (Student are questioning the board about how those racial statement makes students feel). You all got the nerve to say this about students, but you all can stay here and not say a word. You all are waiting for this meeting to say more stuff right... (Student is mentioning to the board that ASI is giving the ASI president anxiety)...Just because you guys vote no confident for President Covino doesn't mean you are with the students. I don't see you all out there with the students or getting information out there like she is doing...
- Dena Florez: As the ASI manager I am in charge of the office producers. I don't believe we have had a conversation about this at all. If there is an issue with the front desk it's office procedure and this hasn't brought up to my attention.
- Nia Johnson: I didn't bring it up to you because in term of the executive director, due to the communication that we see in the office I haven't been able to look up to administrator support to resolve this issues.
- Dena Florez: If I may, we always say we can't address something with staff members if there's anything that goes down because as the office manager this should have been brought to my attention so I may address it...
- ▶ Jocelyn Vargas: I did email Nia about wanting a respond, I know you were busy however I brought up the concern in an email. I don't know if you got it. Marcus and I really wanted to have a conversation with you and again I don't know if you have read the email. About the past meeting and the lack of support in the college rep meeting. Unfortunately you weren't there and you haven't been there for the past two meetings. I have not receive any email and I just want to clarify that if you want to talk after this. I want to ask about this and I was also added to an email thread about facilitating a conversation and I haven't heard back. I was added to an email thread saying... (Jocelyn Vargas is reading the email thread that she added in). As for Marcus support, I believe his door is always open if you wanted support, I can always go talk to him. He is helping us with destress event last minute and I know Marcus is always there...I believe that pictures speak louder than words. I have received a picture of the screenshot saying to vote no confidence and you actually liked that comment. As policy 04 section 8... (Jocelyn Vargas is readying the policy to the bored).
- Nia Johnson: To address those concern you aren't the only college rep who responded to the email. I want to say those experience does not reflect the board.
- Jocelyn Vargas: I would want to hear the concern about those who did not respond, what do you guys think about that?
- Nia Johnson: They are free to talk...They are free to speak to me in my office. Liking the post was so they know that I will address that with them outside one on one...
- Student: I know you all are tired of us bringing issues to you...after the board vote no confident and see how you are treating the ASI President we can't build relationship...(Student is telling the board to keep their personal issues aside). We pushed so hard to be on the agenda for the academic meeting and it didn't even happen. You all are saying that only Nia can bring it up, yet none of you are working with Nia. (Student speak about the board feeling pressure by the faculty).
- Jocelyn Vargas: Is it to voting on the resolution?
- > Student: Yeah, is it you? (Student is pushing the board to say who felt pressure by faculty in voting yes to the resolution). Faculty is very honest with us and no one is going to say it? To get to my point, to even talking about faculty knowing he was the only one. Now you are risking his

- job...What are this side conversation, excuse you, Office Manager what are these side conversation...?
- Nia Johnson: The justice is recommending that we talk a pause. Would you like to continue to speak after we come back?
- Student: So 13,000 students on this campus voted the next ASI president. That means 5% student voted for this president... this represent the dissatisfaction and prevalent of the board. (Student is voicing how the board is not structure).
- Ed: I'm a community member, I have seen one group after another after another running for president... they go in there with full excitement and willing to make changes but when I speak to them at the end of the year they said there wasn't enough time to do anything...This is the first board that a lot of stuff had happen. (Ed is voicing his opinion about the board feeling pressure by faculty to vote no confidence). You can pass a resolution to change the name to ASI.
- E'Leaya Harris: (E'Leaya Harris is voicing her disappointment about the racial slur).
- > Student: (Student is saying how the administrator is discrediting Nia experience).
- > Student: (Student is voicing that one person's experience is not the same experience for all).
- > Student: (Student is voicing that the board is not structure and they should be voted out).
- > Student: (Student is voicing about the support they felt coming from the ASI President).
- ➤ Jorge Salazar: I want to say that I'm very new here and I've been independent. I would like to stay neutral. I always been receiving support from Marcus and he has always been there. I'm not defending Marcus... he has always been supportive. I would never say or do anything bad toward Nia... I think it's hypocritical that we are here bashing on Marcus. Nia has feelings about being bash by the comment I would be to... (Student is voicing that this is the same). It is kind of the same if Nia... no body said a racial slur to Marcus but we are here bashing him when some people haven't even work with him. I know everyone is here knowing that we shouldn't be here doing this.
- Selene Castillo: My heart is pounding really hard right now. I'm going to address some of the question that have been around. I understand that there's a lot of rhetoric going on right now...I hope we get over this problem so we can all come together...
- Nia Johnson: For those who felt attack in the meeting when I wasn't here. I just want to say that this meeting is open to the board. (*Nia is voicing more about how the board felt uncomfortable when the student voice their opinion*).
- Selene Castillo: Personally I'm not afraid of the administration...I don't want to let down my team because they have done so much for the student.
- Dena Florez: I just want to say my statement was no way to discredit Nia statement. We have a good relationship when there is a business matter. I'm saying because I support her and if this had ever happen, she could have come to me so I could have address it and this is very serious. Because of our relationship there is no reason why she can't come to me.
- Nia Johnson: (Nia is voicing about how students are congregating in the front desk and just because the staff doesn't see it doesn't mean that's not happening). I have ask Marcus for support and there was no support there so I have to ask support from other admin... (Nia mention about how Fritza, Jocelyn, and Isai not feeling support from the ASI President).
- E'Leaya Harris: Public forum.
- Student: I'm truly disgusted by how it started. It's nasty that this is the board that is support to be for the student but you are all here talking about problem with in ASI. I am here to speak as a student and I'm not here to defend anybody. I, as a student have been working with Marcus and he was always there to support me and like you all want people to respect Nia that should goes the same way for Marcus... as a leader it should go both ways. You have to realize that this is one person and there's a lot of you guys. I wouldn't just sit here if I wouldn't feel like I need to defend myself. If you guys had anything against him, his door is always open and I'm

- sure he is willing to help. We are all students you have the power to walk in that person's door or face to say can I please talk to you...
- Nia Johnson: My door is always open like, so that matters like this don't get discuss here...Due to the fact that members of this board and the staff have lack of communication that what we should work on...I don't want to violate Marcus's comfortability. (Nia is voicing that voices can't be empowered because she can't have a one on one meeting with Marcus).
- Fritza Plasencia: I heard what you guys are saying. Speaking for myself I want to say that I know there's a separation and I don't like it. I don't want a separation because we were elected by the student for the students. Marcus has been supporting me unlike the Nia has been for me. For my direct report she has not met with me for over a month, she didn't show up to the meeting that we had. She didn't give me any reasons why she couldn't make it. I don't know if you can see but I am 7 months pregnant and I drove 30 minutes to get here so I can met you about the event. I understand that this is an internal problem but I have hear no response from her so I just want to bring that up here because I have not heard back from her.
- Nia Johnson: The meeting that she is referencing to is the one from the Chancellor office where we went to advocate for the student. We went to discuss about the impaction and I have inform everyone from ASI about it...
- Krystal Rubio: I just want to add on. I didn't know there was racial slur going on and I wouldn't attack Nia, she knows...I think this is super dramatic... It sucks that the entire board is discussing this right now and not discussing other issues...
- Student: I feel like you guys are saying that this is not a student issue. She is a student and this is a student issue so stop saying this is not a student issues.
- Krystal Rubio: Ok then, this is a student issue perhaps...
- Student: (Student is voicing that the board can't communicate properly).
- Student: (Student is voicing that there are staff positions because students need direct support. Adding on about just being there is a lack of support from Marcus doesn't necessarily mean there's no support. We are saying that all go to Marcus to go Marcus, this creates a lack of communication with Nia. Student is voicing about how Marcus is trying his best within the space he have to support everyone and not just Nia).
- Marcus Rodriguez: kind of going off of that too. We are in the position of hiring another position. Before this meeting I have received an invite about the meeting that was sent from Keomi. (Marcus talks more about addressing the issues and having his door open for any help).
- Student: Your intention is not to have a lack of respond but because you don't respond it might be coming across that way.
- Student: (Student is saying that she is not comfortable speaking to admin in close door space. Student is apologizing for her rude comments).
- Student: I just want to say that if you feel uncomfortable speaking to someone remember that you can always bring someone else. For instance the two on one where Marcus need support...Second, bringing this issues to the public. Actually, as procedure follows if there is someone else that she feels uncomfortable to go to, there is always someone else after that. (Student is speaking more about the chain of support student may use if there's needed for support). If you don't test the procedure how do you know it doesn't work.
- Nia Johnson: My procedure is to get direct support from Marcus because he is my staff support... (Nia Johnson talks more about how the producer work and also the lack of communication).
- Ed: As we know the board is very disfunctional...I'm going to criticized Marcus here. Two, three weeks ago, Marcus keep saying no that we can't put the resolution because of this and that...ASI do not represent the students. This is the first board I've seen that actually respond to students.
- David San: I don't want to attack or defend anyone. What my title is secretary/treasurer which is doing a lot of paperwork and timely work. I noticed that some people, for the bi-weekly sign in, I

noticed that you sign in the time slot at that time that you weren't there. (*Nia is voicing that she have special access*). You have also mention that your door is always open but one time I asked Keomi about you so I may talk about the resolution. She had mention to me that you were not in the office so I went back to do my work and then the next thing I saw you coming out of your office then going back in...You mentioned about posting the agenda at 3:45, looking at the paperwork it was passed that so the agenda didn't follow through. For the college of commissioners some of them were waiting for you to meet with them but you weren't; responding. I know at times it's hard to get a hold of you like I mention before I'm always there to start at 7:45 and I always see the door close.

- Nia Johnson: My door is open at office hours. It's always open if you wanted to meet with me. (Nia Johnson is voicing about her door being open when office hours is and closing when it's not). Beside from that my door is always open for those who wants to meet.
- Selene Castillo: I would like to see the other agenda that you have made...If we have stuff against to each other we are going to get nowhere.
- Nia Johnson: (Nia is voicing that ASI should enhance the internal communication so things can get done).
- Selene Castillo: Ok, I voted yes on that resolution. I think one of the thing that pop up like Vero said "what is the next step". I am afraid of that too... (Selena is voicing about the how the board should suspend the rule and add to the agenda).
- > Student: Is there a way the student can file a lawsuit of the building in King Hall...they stated that the elevator is supposed to be working but it's not. This is for the safety of the students.
- > Jacquelyn Acosta: If you want you can meet with me after... (Jacquelyn Acosta is directing the student to the right place).
- Student: (Student is informing the board about her concerns for the student being in King Hall.)
- Marcus Rodriguez: (Marcus Rodriguez is informing the student what she can do.)
- > Student: (Student is voicing to the board that he feels pressure from the administration.)
- Student: I'm studying history... (Student is voicing the importance of having an efficient communication and how ASI system is broken. Student want the board to rearrange the tables.)
- Student: (Student is voicing the importance of voicing their concerns.)
- Selene Castillo: Do you want to change the structure.
- Student: Yes please.
- Student: (Student is voicing that the faculty wasn't attacking the board.) We are here as student and demanding that you should be here for us...Your structure of government is not democratic...
- Student: (Student is voicing that not all ASI members need to be involve. The students can help with being involve.)
- Student: The more student rep the better... (Student is voicing that she is waiting for the respond from admin. She is also informing the students that if they want to be involve, they should join committees.)
- Nia Johnson: (Is appreciating the senators are here to speak.)
- Student: (Student is voicing that student should be in committee so they can make a change.)
- Student: It's good to collaborate...seeing how ASI work... (Student is asking the voting member in the academic senate if they may amend to add item on the agenda.)
- Student: (Student is answering the student question.)
- Jacquelyn Acosta: (Jacquelyn Acosta is informing the board that the academic senate function differently than Board of Directors.)

#### a. No confident Resolution:

- ➤ Nia Johnson: They have about 70 board members. You may reach out to them to help us to communicate with them. You may look at the academic website what it's about.
- > Jacquelyn Acosta: (Jacquelyn is informing the board the website.)
- ➤ Nia Johnson: If you want you may look at the academic senate membership. We should draft up the email sheet with all the faculty name so that you may set up meeting. This may add pressure when they see the email.
- ➤ Aaron Castaneda: Are we signing up people?
- ➤ Nia Johnson: We are, I also noticed that there are some people who are more comfortable speaking to faculty then others. Such as the college rep because they have a specific college they are assign to. But for you, I don't know if you only speak to your specific college faculty.
- > Aaron Castaneda: I do, I only see two Business of Economic people that I know. I would reach out to those two...
- > Student: (Student is recommendation how it should be.) How would the conversation go?
- ➤ Nia Johnson: The first thing that I would recommend since we do have the resolution on our website. We should open up the resolution for them and speak of the resolution, maybe opening it up from the ASI website for them. We are also doing the same thing and maybe speak on what is important for the students. My goal is to get the academic senate to support us with this resolution...We should also voice that we are not the only one.
- > Jacquelyn Acosta: We need to talk about how to get it on the academic senate. Since it's not on it as of it right now so it might not be on it but we should give it another shoot. (Jacquelyn Acosta is making recommendation to the board don how to get the item on the agenda.)
- >Student: Do the administrators and students know that ASI vote no confident?

- Student: I can connect you to them.

- > Jacquelyn Acosta: That means when their term is done.
