 - a. Discussion
 - Nia Johnson: Alysin did begin her time in ASI though in the term to her email she had stated that she had an internship and committee. She said she would remain to communicate but she didn't respond to her email. She also was the first person to get appointed as the college of art and represented. So, when Isai Amaya came in, it was her responsibility to introduce him on the update. Isai Amaya himself was having trouble to communicate with her. I wanted to set a meeting with her as well so that she may work more effectively. She did respond to some email that was sent to her which she stated her experience that she had with the loss in the family. She also stated that she accepts anything that the board want to discuss.

 - Isai Amaya: I talked to her and I understand that she was going through stuff. I didn't hear anything from her, she prioritize her target more. She basically not putting any effort to ASI.

- ♦ Jennifer Martell: I don't know if you're looking at the email that I sent to her about her all her absentees, these are all the unexcused once.

IV. Discussion:

- a. **Policy Agenda Development** The Board will review the Policy Agenda and brainstorm more policy priorities that reflect the Cal State LA student body needs.
 - ♦ Veronica Garcia-Martinez: so, I don't if you remember that we were creating the policy agenda for CSSA for student who have the issue. This is what we created and was sent to CSSA. What we are trying to do now is pointing out more issue at CSULA. Given that we are opening up discussion if there's more issue and how we may expand more and publish it and share with the campus.
 - ♦ Nia Johnson: Give the board some information that I have for CSSA that 70 % of the student are receiving Pell grant and 41.6 % are for food and secure. We have the higher percentage of food and secure. But we still don't have the fresh food for student. I would open it up for the rest of the board for brain storming for CSULA student that are facing. If you know the problem we address it.
 - Rashad Freeman: outreach the recruitment.
 - Nia Johnson: well have to do more recruitment.
 - Aaron Castaneda: I think one thing that is challenging is the ideas and how we are going to do it. We know we have issue but how do we encourage to think critically. We are not solving the problem right now we are just pointing out. We should think of strategically and planning to solve it.
 - Nia Johnson: there's pizza of president this Friday. We want be solution oriented. Yes, we might have problem, but we should have solution as well.
 - Raul Rodriguez: Tell the student what this college offer so, it may be a great benefit to get them on campus which including minority. I know we can have further discussion.
 - Nia Johnson: To say what CSULA's basic need and we have this document to draft up solution as a student leader. What can we do base on this document, so we may collaborate?
 - ♦ Jacquelyn Acosta: In King Hall, there's a lot of traffic which is absolutely ridiculed. As for CSULA renovation, they are working on one building at a time. Realized we don't have enough money to work on all the building at once. I

- have discussed with Jennifer Miller on how the building is done. There's a lot of different things but things need to reword it.
- Jocelyn Vargas: Agree to what Aaron said, problem solution oriented. One of the idea that was brought up is the concern about ICE. What happen if ICE where to come on campus if we may help student with that. Maybe have a text to tell them.
- ♦ Jennifer Miller: If ICE come on campus it's a federal agency, the only thing is public safety. We don't give out student information. In that point they have to give us a reasonable reason even if they are federal agency. We are providing the Rights card for student who they don't have to speak. We don't collect information of students.
- ♦ Edgar Chavaz: Following what Jacquelyn Acosta was saying priority number 3. As you know they are moving faculty, so they may finish the building. It's not easy to just build parking lots because again CSULA is up to the mountain so there more to it.
- Rashad Freeman: Everyone is putting good input, priority number 2. Having more food option for campus.
- ♦ Jennifer Martell: Changing up a little bit more by having more food option on the other side of campus. I would love to see a microwave there. I see snacks but they're not healthy.
- ♦ Jocelyn Vargas: Having more option for vegetarian and vegan student. Maybe having more food option and label for awareness for student who have special condition.
- Davona Watson: Adding on to Rashad, hot food program has requirement and we want healthy meals.
- ♦ Jennifer Miller: You do have an open spot and EBT is going to be available this year. Fresh food is one thing people can buy. But we want more fresh fruit and veggies. We also have meal share with housing. Anytime you want to know what's going on contact me. We make a solution but also want to know what existing.
- Nia Johnson: Echo what Jennifer Miller, they offer us a resolution that student who have meal plan and don't use it. May they allow to give those opportunities back to the program to give the student who doesn't have it?
- Jennifer Miller: Again, we do have it, it's called the meal share.
- ◆ Aaron Castaneda: CSSA last year we introduce the emergency housing. I'm working with legislators.
- Nia Johnson: Brandon who is a staff for CSSA participate in writing letter to the local. We know how effective of how student voice can be.
- ♦ Jocelyn Vargas: I wanted to go back to priority number 2 and say good job I know you been working hard. One of the concern when they give food form the pantry they should give out recipe.
- Jennifer Miller: We are working on that too, and we are doing cooking demonstration. We have the opportunities to teach student on how to us knife property.
- Nia Johnson: Additionally, now that we have this information and how are we giving this information back to the student?
- Davona Watson: Wanting to review this information to the people as college student we are not eligibility.
- Jennifer Miller: Cal fresh use the money on their EBT card. They have to have the fresh fruits and veggies.
 Bookstore and library are working with us.
- Davona Watson: Is it going to be prepackage?
- Jennifer Miller: They get to determine what they want.
- Davona Watson: Some students can't be eligible for hot food what can we buy?
- ♦ Jennifer Miller: We have the Cal Fresh rehabilitation.
- Aaron Castaneda: One thing we shouldn't put aside is the ADA compliances. I know some point king hall the elevator doesn't work.
- ◆ Raul Rodriguez: This information should get share?
- ◆ Jennifer Miller: Yes, we are doing that

- Jocelyn Vargas: ADA today I was tabling and there was a concern student who lived in housing I don't know if we
 are working on, but she is having trouble to get to class because of her disability need. I suggest may be offering a
 shuttle.
- Jennifer Miller: There is a shuttle for anyone who need those type of help for disability for their schedule just for \$1 or \$2 plan.
- Veronica Garcia-Martinez: I wanted to say these are priority in front of us. Feel free to add on.
- Rashad Freeman: That there isn't a lot more temporary parking.
- ♦ Jocelyn Vargas: Transportation, I don't drive. It is difficult to get home after nine because it'll be too late. There's only one shuttle that take me back.
- Nataly Aviles: there's another one by biology building, it's right on the edge of the campus.
- ◆ Isai Amaya: priority number 3, a student asks me if the campus ADA compliance. He came from ELAC, he's been having trouble to get to class. The elevator was broken so he had to move his car to a different student. He stresses that he felt bad that his whole class have to move just because of him.
- Aaron Castaneda: Commute student are taking the bus. We need to work with metro and to keep the u-pases in a good price.
- ♦ Jennifer Martell: I'm going along with Aaron we need to look further beyond the parking. Too many class are schedule at that time. Class are being offer too much at that time.
- Nia Johnson: The classes are schedule now is for student who need to graduate 4 or 5 years.
- Jocelyn Vargas: We need more public safety are the bus section at night.
- Veronica Garcia-Martinez: Going back to Aaron we have metro link working with us as well as with another CSU. We want to see if we get student leader to come out sharing their experience. We'll have the metro link fair for student to know the resources we offer. It is much selected for those who are going to attend.
- ♦ Isai Amaya: Two thing, for parking situation is there only three main street ways to enter CSULA. As for priority 4 is having more safety.
- Nia Johnson: We need to build a relationship and try to build that connecting and communication with public safety. Include public safety as a whole so we may build that connection.
- Aaron Castaneda: Making academic priority.

- Nataly Aviles: So, Luz, she told me about this event called the Up to Us. This event is about how to create programs or events to become a team, so we may create programs that improve our campus. The best ideas win and 10-thousand-dollar grant. If you are interested tell me so we may form a team.
