II. Public Forum:

 - Unknown Speaker 1: I do want to address some issues within EOP Special Admin. One thing I want to ask is how we can work together as ASI and student engagement so that we may work toward to having better solution. Also simplify the language so that students are able to understand and we need to improve our communication. (Unknown speaker 1 goes into more detail regarding how beneficial it would be if ASI would collaborate with EOP. As well as different ways ASI may advocate for the students.)
 - Unknown Speaker 2: My issues is being a commissioner I would like to add the amendment to postpone the policy. Reason being is because in the policy, when I was looking at the requirement and the ability I saw nothing that was advocacy with the RA's. (Unknown Speaker 2 goes into more detail regarding why it's crucial for ASI to advocate for RA's.)

 - Veterans Affairs Representative: (Joel Cook is given 1:30 seconds to say why he is qualify for the position.)
 - 3 Questions:
 - Rashad Freeman: So in your resume or the application process that you are focusing on Veteran's Success. How do you put in work playing a role in focusing in the Veteran's success?
 - Joel Cook: I believe the important things that veterans do for me is engagement on campus. One of the ideas I have is further increase engagement between non-veteran students and the veteran students. (Joel Cook goes into detail regarding how important it is for non-veteran students and the veteran students come together.)
 - > "Jocelyn Vargas: What you do think are the big challenge that the veteran students face on our campus?
 - ➤ Joel Cook: That's something I actually thought about myself, I think that It can feel very difficult to immigrate yourself on campus and in student life. Being a Veteran student is an interesting, kind of unique experience. You have serve your country, you've been exposed to being alone and you been expose to maturity. One of the taught things for my self is to connect with the large community of students.
 - > Selene Castillo: Why is it so hard for Veteran students to connect with other students?
 - Joel Cook: I say the toughest thing is that...a lot of times, for Veterans it's the age gap and maturity both. Sometimes people come from a different background and those different experience makes it hard for some students to connect with other. Also it may be maturity issues. Veteran student are good on focusing on a goal and achieving it as quick as possible. (Joel Cook goes into detail regarding why it's complicate for Veteran student to socialize.)
 - II. Discussion:
 - Matthew Keels: I interviewed Joel, before I took this position I promised that someone would take my place. He was actually supposed to take my place in fall and he's actually been shadowing me since the beginning of last semester. So, he should know everything that's been happening in the Veteran affair. One of the thing that stood out to me is the fact that he wanted to bring that gap between the Veteran and the non-Veteran students. - a. Academic Senator at Large (Undergraduate): (Raul Rubio is given 1:30 seconds to say why he is qualify for the position.)
 - 3 Questions:
 - Rashad Freeman: In your application process you have discussed that students are having a hard time in term of getting guidance. You followed up with claims and ideas that you may minimized. So, what are those plans?
 - Raul Rubio: Yes, that is correct. I was a victim of that, I was told to take classes that I didn't even have to take. So, that was a lot of valuable time that was bit spend correctly. As far as my plans, there is a lot of students like I, didn't voice the problem. - a. ASI Funding Sub-Committee Student Committee Member: (Jordan Smith, Sharon Pelaez, Tu Nguyen, and David San is given 1:30 seconds to speak on why they should sit on the committee.)
 - 3 Questions:
 - Christopher Koo: How do you intend to make sure all the club are aware of the policy?
 - Sharon Pelaez: That's a really good question, I have already told a bunch of people that I apply so if they needed any help they can come to me.
 - Tu Nguyen: One of the things I would do is go to the club's meeting depending on my schedule and see if they understand. IV. Information Items:

- a. SPECIAL PRESENTATION (4:00 p.m. Time Certain) Provost Lynn Mahoney: The Provost will present on Cal State LA's enrollment and budget challenges and the subsequent need to further extend the University's impaction rules.
 - Provost Lynn Mahoney: I want to thank you all for having me. There is nothing worse than having this discussion about these issues and nobody shows up. That is a sign of an unhealthy institution, so I want to thank you for those who shows up. Let me start by saying the word impaction has a bad reputation because it had used some of our system campuses to change the mission of the CSU. So, people who hear the word they immediately think that's what we are doing, we are not doing that. This is not about changing out Cal State LA, this is about managing our enrolment of budgeting. We are an impacted campus and there are people out there who do not think otherwise. We have been impacted for 10 years, what we have been talking about is modifying our impacted role such as reducing access for transfer student. We are not changing our mission (*Provost Lynn Mahoney going over Cal State LA mission statement with the board.*) The good news is we have been successful in all of this. We have been increasing our student's headcount on campus by 27% in 6 years. We have increase our 6 years graduate for freshman by 18%. We increase our four-year graduation for transfer student by 5% to 75%. Our success comes with enrollment challenges and each year we increase our enrollment by 27% to 28%. But we only increase our funding to 2% so we are technically short 32 million dollars. If we were

fully funded for all those students, we would have additionally 32 million dollars. This means we are serving those students with our state support. We can't control freshman, but we can control the transfer student who are coming in. We have reduced classes for transfer students in order to sustain. (*Provost Lynn Mahoney speak more on the enrollment and budget challenges and the subsequent need to further extend the University's impaction rules*.)

- Fritza Plasencia: Are you just saying no to them when they apply or are you making the standard higher?
- Provost Lynn Mahoney: So, for right now student who are non-local and do not have the eligibility get automatically deny. The only way we control the enrollment is by raising the standard for the non-local students. We have to push away our non-local students away.
- ➤ E'Leaya Harris: So, I'm a transfer student. I came from the valley. I transfered in 2007 so, with this new impaction would that means you guys are not accepting students from the valley anymore?
- Provost Lynn Mahoney: So, transfer student, we want to have control because we want a balance with local and non-local student. So, our transfer class are half and half. It's the freshman level where we do not have control as much.
- Nia Johnson: A pond speaking with President Covino this process would not affect the EOP. But we are not 100% sure, may you clarify if this would affect EOP?
- Provost Lynn Mahoney EOP, Special Admit, had one thing, students who meet student with the general criteria. With the special admin it said we can give access to student who are below within 2019 criterial. So, in our action proposal, in our plan for our alterative admission program that's a different language and that's what the president was talking about. The alterative admission program is for students who do not need a number but have and exceptional scoring or having an exceptional leadership. They also have to be first generation low income. I think there will still be a path for student to apply on their raw score or number.
- Matthew Keels: Thank you for coming out, I am not too familiar with this as well. I had gone through something with the campus, so if the student gets deny here then we can still look for opening in another CSU, is that still happening?
- Provost Lynn Mahoney: Any students who apply for CSU is guarantee to one university. For instance, if you apply for Long Beach and Los Angeles and you didn't get into both. The system will tell you which college have an opening spot for you so you'll be given a chance to go to another CSU.
- Selene Castillo: First, back to the EOP. So, I think you said that they have to meet a certain requirement?
- Provost Lynn Mahoney: Yes, I believe you have to be low-income.
- Selene Castillo: I don't know so much about the application process, but how would that be?
- Provost Lynn Mahoney: I'm not certain about the process on how EOP does it. Though what we are talking about is creating an alternative program so that students can apply who didn't make our criteria. The kind of things we put in is the student who have an incredible leadership from high school who live from a car or any hardship. We are preserving and alterative root, it'll just be more holistic then EOP.
- Selene Castillo: I'm also a transfer student. Transfer student who has meet the requirement well have the same chance to as a local student.
- Provost Lynn Mahoney: So, no there also local transfer students. We have in that book we have 7 local community colleges and 7 outside. So, 9 community college if you met the requirement and have a 2.9 GPA. Outside that box, you do get rank to get accepted.
- Edgar Chavez: I want to yield time to Unknown speaker.
- Unknown Speaker: I apply for CSU Mentor and you get these simple questions asking about your high school experience and how it impact society. I just want to say that it's not just students who miss that SAT score, I want to say it's a little more than that. In my experience I had a 2.4/2.5 GPA and I was told I wasn't going to go to college. I almost didn't graduate and

- now I'm in college with a 3.6 GPA. So, I just want to clarify that it not just students who did great but got a D in the last semester. No, it's pretty much harder than that.
- Provost Lynn Mahoney: You're right it could be a GPA you're missing it could be the SAT you're missing. I'm confident about what I hear what you did in high school. I bet you were doing other stuff that was very interesting. There is a story there that if you look at it closely it'll show why you are here today. This program is to help those students and it can't be thousands of students because then we will not balance out. We want to find those students and give them a second chance.
- Unknown Speaker: Why do we have to construct a new model when we have EOP?
- Provost Lynn Mahoney: We haven't even decided to do the model. We are just asking for permission to do it. But EOP one limits who can apply to. Recently a young man was brought to my attention. He doesn't quick fit the EOP model but boy he is a spectacular student here and his not eligible for anything. So, in his case I think EOP critical is for low-income and this student is just right above that. He is not a rich white kid but he's not eligible for EOP.
- Unknown Speaker: Think about class issues. Think about students who are from high school and are working there hard to be CSU or UC eligible and how some might not have those class accessibilities. When I go out and talk to students I always talk CSULA and how great it is and how the student engagement is amazing. I always talk about the community here and how it so rich and different from other campus. I feel like we need to see another alternative.

- Jacob Isai Amaya: I just want a clarification. When you were talking about the transfer from local and non-local student, do you mean that a transfer's student that's non-local needs and A suppose the local student...
- Provost Lynn Mahoney: It's actually the opposite. Any student in the box, we have two that are local. So, these two they have access to Cal State LA. Students outside the box have access to Northridge.
- Selene Castillo: Why can't we have more system such as EOP?
- Provost Lynn Mahoney: At the end of the day it's all about money and the funding. That is what exactly what I'm talking about. (Provost Lynn Mahoney mention more about how if the school have more funding, there will be more programs.)
- Fritza Plasencia: Using this local map, who determine this?
