#### II. Public Forum:

a. This time is allotted to members of the public to address the board.

- Nia Johnson: I would like to say we do have snacks in the corner. As for a general announcement, I would like to say that the public will be provided with three minutes each for public comment.
- Speaker 1: So first of all, I liked to mention that there's a King Hall rebellion because of how outdated the facility is. There's been students and faculty who had been stuck in the elevator for at least 30 minutes. I also want to take a look at King Hall classroom seats 310. We have chalkboard with holes and my professor has to write around those holes and I don't understand why we are paying tuition. Other things I have concern about is that we are still paying for parking, \$200 a semester and we still aren't guarantee parking. We have Valets, which I don't understand why we have that either. I notice we have a lot of online classes; I know a lot of community college like PCC and ELAC are way more advance than Cal State LA. The fact that we are a university we are supposed to uphold that value. If you go to Long Beach and Fullerton I feel like I'm going to a university. When I come to school here I feel broke. I should not feel that way especially with the tuition I'm paying for. As well as faculty for funding that was approved, where is it? I just want to let you guys to know that, as much I have hate saying it, but it feels like I'm going to a rundown of community college I feel like we need to... as the funding that was approve we don't even know where it's going. We know where the pocket it's going. We should take it out of there and use that for our university.
- Speaker 2: I just came here to say today that we are...we want to know where ASI stand on impacted because we know you have made a statement saying we heard you and we are trying out best, so I just want to know where you guys stand. What we are going to introduce you today is really take action on what you are going to do. We know you have a privilege being able to work with administration. We would like ASI to use your spot your position to really hear the student voice and maybe you can explain it. We want to ask you to really just do your job, we are not trying to bash you, but we are short ended in terms of working with administration. We are concern that our issued wasn't even address in the campus wide email saying yeah, we heard what you were saying but we are still carrying on with impaction. They didn't even mention what happen in the public hearing but at Cal State LA here they didn't even mention that Covino walked out on us. I had to say Covino what do you have to say about this? And there was no respond. He didn't even show up to the academic meeting, he is just nowhere to be found yet he has all these administrative meetings where faculty have to ask provost Mahoney to say student should be in this space. Nothing was being sent out so that's basically that's what I'm saying and thank you.
- Speaker 3: I like to thank Dannielle because I have so much comment to make. On this campus there's two different visions. I would like to say that the students and faculty seeing a campus that primarily seeking a mobile campus where they try to leave from poverty or privileges to enter

the middle class. There's another vision where this campus is starting to run like a business and in a business the CEO where he or she shows where they have seen an increase if profit. The kind of people you see in the news are aren't just people who uses guns to get in school but money too. We are on this campus we have to power to reverse this. ASI is a like business. This shouldn't be a business it should be ASG Associated Student Government.

- Marcus Rodriguez: I just want to clarify things what you can come back to public forum. When you are doing discussion, you can also involve the public forum so that you get to hear all student voice. I just want to present that
- Speaker 4: The person I wanted to talk about just got here. But we wanted to present these signatures. It's over a thousand signatures from community members to impaction. This is to inform the students showing that in Cal State LA there was no interpreter for students. This was also for alternative for faculty to want to keep the students out of the spaces.

#### III. Special Presentation (time certain 3:30 pm):

- a. Provost Mahoney will discuss modifications to the Admissions Proposal and the impact of a one-year moratorium.
  - Provost Mahoney: We are here to give you three updates that we received form the president which is something you can see on the website. But mostly just answering questions and hearing your concerns. So, we conclude the connotation process and I was aware of this position. We also impose the public comments in the enrollment proposal website. As the president put on his email, our challenges remain the same. We have received a head count about 5,000 of you did not received state funding. Which means we do not get funding to hire 10-year faculty, academic advisors, counselors, and other service that can support the students. We did listen to the thousands and thousands of comments we got, and we did an altercation. The first altercation is that we are making no changes to our local community college. Some of our students and even some from ELAC. As for the second change, which is that, we need to continue the new politic recognition. So, one of the executive committee was asked the president do you agree to form a joint enrollment act, and enrollment joint task force? The idea to the task force would be short term to allow the academic to create an academic university policy. The president had agreed to create an enrollment task force. There will be recommendations made to him for the admission criteria for fall 2020-2021. That would be the data that the academic will be creating the committee. The committee will have administrators and we'll have the task force. Eight faculties will be on it and the director of EOP, Dean of Students, and the co-chair like the academic chair and myself. So, the job of that task force is to make sure the conversation is collaborating and transparent recommendations that are being made to the president.
  - Marcus Rodriguez: Board members you do have that as an attachment.
  - Jacquelyn Acosta: So one of my question is since we are forming a task force would administration have voting power?
  - Provost Mahoney: The committee is to make recommendation to the president. So that is not generally done by vote.
  - Jacquelyn Acosta: Just because you said standing committee?
  - Provost Mahoney: I'm talking about the task force right now, I do not want to presume what will go through the senate process what it include with. But the task force is like an advisement.
  - Jacquelyn Acosta: My follow up question is what is the other administrator doing to high school students? I asked this because it'll be affecting the incoming freshman. Is there an outreach for the high school students because I believe they should know about this?
  - Provost Mahoney: So we've met with the president of the board of education. So High School students are aware of all the task and result. In the task force there will be ELAC representative as well as another CC representative. We will have LAUSD representative too. As of the spring, we did talk about our enrollment challenges but as of right now we have no direct communication. Until we submit the proposal, once we have it back we have to respond.
  - Aaron Castaneda: Can you tell us where does the university stand on the one-year moratorium?

- Provost Mahoney: The challenges we brought to you stayed the same. Indication that our local freshman number is up again in this fall 2019. And the only way we can control our number is reducing our transfer class. We control it because we do not want a large number like last fall which was more than 28,000 people. You also heard from transfer students, PCC, and many more.
- Davona Watson: I want clarification about the two-student representative for this task force. I don't know, are the two positions may be ASI representative and how may we offer those space to student at large?
- Provost Mahoney: So we have a couple people who are working who should be on the chair. I might have to...
- Nia Johnson: So, in the beginning we have made an amendment to move the topic to informational item. I do have a position in the committee. I do want to make sure to open that up so that I don't appoint myself. So, if you are interested in sitting there please contact me. I will be having a seat, but I do want to get more students there.
- Provost Mahoney: This is going to be a short term. (Talks more about how the way the standing committee will look like).
- Selene Castillo: Allow 3 minutes.
- Speaker 1: So now the provost is here we have a question for her. We realized you can't wave a magic wand and make 30 million dollars appears. We realized we are in a budget constrain but my question is, why aren't you publicly condemning the underfunding of Cal State LA you could call a press conference and demanded full funding for public education. In doing so you can show that you are representing the students and family of Cal State LA. Even if you can't make that money appear you can at least change the way you use it to demonstrate that you are with us.
- Provost Mahoney: So for this process, in fact your president of provost use... There are multiple processes to advocate for this. Everybody has a different way of doing it. As your president of provost, the best way is actually go with the system even though you are agitated for change. That is a different conversation, but we have done... starting on October. The president and I have met regularly with the people at the chancellor office to advocate for more funding for Cal State LA not just the CSU but for Cal State LA. We have provided them with our data and how we are underfunded. The president has gone up to Sacramento to do the big ask for more than 2% we've been awarded. But everyone has a different way, and everyone should know that no one has work harder than president Covino as for getting funding for Cal State LA. His approach however might not be public taking on the governor. This governor, compares to the other governor has never offered us a friendly handshake... this will be our first. First our president need to approach this in a certain way that other groups may not do that same and I'm respectful for all those approaches. But the president is advocating for the students.
- Krystal Rubio: I would like to allocate time to the public... 3 minutes.
- Speaker 2.1 just have a couple of questions. You keep bringing up that we have a nice governor that's giving us these funding, but he gave 300 million dollars to the graduation in 2025... Budget for 2019-2020 300 million dollars for the CSU GI 2025. I can show you and only 15 million dollars for student's basic need and 47 million dollars for maintenance. So, there is funding, but it just need to be use in a proper way. The fact the student basic need is 47% from the 300 million shows that we are not coming first. We do understand that the president and the provost can't act out but that's not what we are asking you to do we're asking you to take a stand whereas we can't work with the system. You have all these students and you know this is very little funding. We need you to invite use to the facility meeting, so we can be in that space. You had a meeting with facility asking how this was...
- Provost Mahoney: That was with the executive committee senate.

- Speaker 2: Another thing is you said the senate would handle the task force thing when the senate hasn't even proposed their whole support on it. They haven't even said they'll take a stand for the students so how would we even know to trust them? I just want to ask is it a coincidence that you came from Long Beach and you declare Impaction there and now you are doing the same thing.
- Nia Johnson: Thank you so much. One thing I like to say that while we are supporting the student's voice we need to stick to factual information. As publish by the CFA the 300 million you are correct with that amount, but that amount is in total. This is not specifically for GI, only 45 million is for GI. But the graduation is only 45 million as for the enrollment growth is 62 million and for operational cost is 193 million. Just making sure that we do not mix up the numbers.
- Provost Mahoney: There is no doubt that the CSU doesn't get enough money. Though even with those chunks of money we still need classroom and other student's services. Everything there is just enough of it.
- Speaker 2: But why do we keep having these facts about...I'm going to speak up regardless what minutes is I don't care I'm a human I'm going to speak whenever I want to speak. Ok, so yeas these facts about this and that.
- Nia Johnson: I'm so sorry but I'm going to have one of the board to allow time for you. If you may please just wait for one of the board to allowed time.
- E'Leaya Harris: I would like to yield time to the public for 2 minutes.
- Speaker 2: It's not a matter of 300 million or 15 million, thank you for clarifying that. So, Overall, I do not want to hear more of this and I think my friends and the people this group are tired of hearing will its ok... we're doing our best. This system is ineffective, this system is broken, and we depend on these people to fix it. No, throughout the history education is not funded. The state of California is the 5 biggest in the world. The fact that we are here talking about underfunding for CSU that's not just an issue here it's everywhere. Education is being privatized. As Mahoney being here doing the same thing how is that even possible. We are bringing this emotion and concerns to you and we are still not being listen. This group of people is nothing compare to the students.
- Aaron Castaneda: I would like to yield my time to the public for 2 minutes.
- Speaker 3: I came from PCC from the fall and just knowing all of this... we already have to pay hush money to make the Dean to resign. I have to hear this here. When is this education corruption going to stop? Education is a right and we should have assistance to it. I have to provide... I'm a student with 3, 8-8. I'm on a Dean's honors list here at fall and my last semester at PCC. Cal State Long Beach was asking 3.2 GPA was my dream school. I didn't go there because I didn't have a 3.0 GPA and Fullerton was asking for 2.0 GPA. How is that fair on my part. I understand the community when the local university has the ability to accept them but now can't.
- Nia Johnson: Where are we right now as for having student seat?
- Provost Mahoney: So right now the task force have been agree to have those spaces. I would encourage you to speak with the academic senator to find out the timeline. I don't know their process.
- Nia Johnson: My follow up question is that providing the campus with open deliberation I know ASI try to provide that opportunity. With your recent statement about closing the public comment I think the message across the campus is that our administrator is not willing to listen to our voice. As student government we want to empower the student voice is there any administrator open forum where you may provide those spaces for the students?
- Provost Mahoney: the proposal that you got information on the website. The proposal is being submit tomorrow but it also depend on we are deliberating. If we are deliberating one-year moratorium the proposal is going tomorrow. I'm open to continue to have these open conversations how to get better partnership with our high schools. My email is always available for students.

- Jacquelyn Acosta: Just to sum up open deliberation. The open deliberation was not only targeted to address impaction, but we have student who are concern the buildings structure parking. Not only that but other issues; and as someone who planned this event 8 months in advance and have the administrators withdrew which disheartens me. This just shows that the administrators did not want to be in the environment where students have questions. To me your job is to be in those spaces. There's a lot of students who deserve those answers.
- Davona Watson: I think that we heard a lot from our public forum and Jacky about how students are not being heard. I also understand that what you said during the hearing that not everyone has equal access to the information. What I requested to president Covino the last week before was that there would be some type of public response that's being posted by myself. We are not going to silence student voices and there will be another time where we have discussion and have public forum. Did president Covino bring that up to you and what was your respond to that?
- Provost Mahoney: So I haven't spoken to him but I do have an open interview from a young women from the university time who I have been spoken to multiple time, I believe her name is Marisa. The academic of senate did list be questions, which I respond to. I posted my response publicity. I am not privilege for that information, but I will discuss with him about it.
- Krystal Rubio: One of the student's concerns was with raising the GPA, I just want to know what your thoughts on that are? Is there an alternative solution besides raising GPA? Provost Mahoney: So, we have about 5 thousand students who are not funded. We did reduce that number. Really the only way we reduce those numbers is by reducing those numbers of student we admit. So, we have been doing that for at least 6 years. Over the last three years in order we maintain that we have to reduce transfer students. The way we reduce transfer student is by raising GPA. At the freshman level we have asked for permission to... in order to reduce the numbers we have to look at the eligibility requirement. (Provost Mahoney talks about short terms and long term of GPA being rising)
- E'Leaya Harris: I liked to yield time to the public for two minutes.
- Speaker 4: I want to respond to your reposes to my response earlier. I want to present a theory of how politician make changes happen. I wonder what history professor of Latin America professors in this school who went a prestige of their knowledge in this school on this type of things. I wonder what they have to say about this theory and history of the way changes happen.
- Provost Mahoney: let me clarify something, I am a U.S. historian. I didn't say that, what I said was the roles of the president and I can play in this moment is advocacy within the system. I also said I fully respected of the multiple ways. So, if you look back at how changes accrued it's a sophisticated complex hundreds of voices are involved and hundreds protest. There are many ways the historian can do but please know I didn't say it could only happen by working with the system. But both the president and the provost can best advocate for you by working with the chancellors and many more but that's not what I said how changes are.

#### IV. Action Items:

- a. Cal State LA Impaction (time certain 4 pm): The Board will take action in consideration of the student and faculty call for a one-year moratorium.
  - 1. Discussion:
    - Fritza Plasencia: From what I understood from the provost was that they are not looking at the moratorium. They have actually disregarded that, so my question is what are we going to do for the students who want that?
    - Nia Johnson: With us making a statement or making a stand. Some of the things we would include in that statement is our advocacy for getting seats at the campus wide committee as well as updating the students on what is being done. We are trying to coordinate meetings with the chancellor office as well as any discussion that happens in the CSSA regarding impaction and we'll be updating the students within our public statement on what happens following meeting with April... Other CSU have reached out to us about the past CSSA regarding the domino effect

that will be happening, if Cal State LA becomes impacted the CSU system is busing at the so Cal region. Another CSU might become impacted as will. This is the statement we will be putting out if we do stand with the one-year moratorium.

Aaron Castaneda: I do support the one-year moratorium. Just for the purpose of... the concern about how to deal with the issue. If we do take action of the moratorium they will know why but I don't know if CFA will take a stand on it. But we'll let them know about us taking a stand, so they understand where our position is.

- Nia Johnson: I really want to stress the domino effect, if this body takes action this is going to be the first body that will take action and a stand on the moratorium. Recently at CHESS we have one legislator who brought up impaction before in term of how we want to support them. If we can further our communication with our legislator, we can leave those advocacies going. We only have 5 weeks left within our term but that doesn't mean we can't make action.
- Veronica Garcia-Martinez: I was a little confused if we were taking action on supporting or not supporting the moratorium, but then we are talking about some of the advocacy that we are already doing. I think those are two separate things and I'll look for the advocacy part of it but yeah, we are talking to the chancellor office and other department but yeah, I'll look furthermore into detail if that's a separate thing.
- Nia Johnson: A stand is saying we support and a not stand is saying we do not support of the moratorium. We are outing this on a CSU level discussion, which we'll be addressing in CSSA.
- Veronica Garcia-Martinez: I'm still confused because what we were discussing was like the service of students.
- ➤ Nia Johnson: The service area is what we call to action. What we are implying is that if we discuss about impaction we discuss service area (Nia Johnson explain more about service area).
- Davona Watson: From my understanding of the moratorium. Within this one unit process there will be a social process, which sees what area is impacted. Though, I want a better understanding that if we do take a stand will transfer student be affected?
- Nia Johnson: That is something that we need to further discuss. That is why we have this space here right now to discuss about this. We do want to look further of what those impactions looked like.
- Veronica Garcia-Martinez: Is it one year or two years?
- Nia Johnson: I was under of the impression that it's one, but I guess it's two.
- Marcus Rodriguez: If you have a moratorium here it'll be one. So, the process is a one-year process. If you count those then it's two years. The effect on transfer students will be two years.
- Jocelyn Vargas: Shout out to everyone who went to CHESS, but I do want to ask if we take a stand and we do have that one year, what else is ASI doing to receive funding?
- Nia Johnson: We would have to check with the provost Mahoney on what their ideas are of working with the trustee or chancellor office. With ASI role is reaching out to resources because as a student's representative and working with the student administrator we want to make sure all the information is out to the students. (*Nia Johnson is informing the board on what ASI is doing to advocate for more funding and make sure the student voice is heard*).
- Jocelyn Vargas: To piggy back off of what you said, I do understand all the effort is being made but... last year when we went to CHESS and we wrote postcard to the Governor at that time is there an opportunity for us to offer that service to our students to write the letter to our Governor now?
- Nia Johnson: Adding on the student where writing letters to the administrator and the university so I just want to make sure that ASI take this on.
- > Krystal Rubio: Moratorium is that the only way? The more we push it back the more it'll fade away.
- Nia Johnson: Just echoing what Provost Mahoney said that's not an option that our administrators are exploring. This is us saying that this is what support are of. If there is an alternative way you like to voice you can do that as well.

- Veronica Garcia-Martinez: I want to yield time to the public 2 minutes.
- Speaker 1: I think that you guys are representatives. I feel like we can be the first Cal State to do something and put a stop to this. We've seen UC Berkley do it all the time. We see them making history not listening to administrators. We have the power, we are the ones that are funding and providing them with the tuition. Obviously the administrators don't care, we need to take it up to our hand in non-violence form. We could be the first CSU to make a change. If you are stressed about this right now I can't imagine what the students are feeling.
- ➤ Jacquelyn Acosta: (Jacquelyn Acosta talks about how important it is for people to come and visit the campus and talks about the issues). We should reword the service we are doing as standing up for impaction. Not a lot of us are for impaction but we should reword what ASI is doing as to empowering students.
- Nia Johnson: Please provide recommendation of our literate.
- Jocelyn Vargas: As it was mention about pushing this back might make it fade away. I disagree that this will fade away because it is impacting our students. On the other hand, what are they doing as outreach? I believe the university should be responsible for this.
- Aaron Castaneda: I want to service time to the public for 3 minutes.
- Speaker 2: She wants to help advocating all students or us. We want you to help advocate for us for student on campus.
