### III. Discussion Items:

- a. The committee will discuss further draft of the 9&3 Budget.
  - i. Christopher said there have been not many changes. The only change is towards ASI scholarships. Pulled \$2,000 out of programming because we had left a considerable extra amount there just in case.
  - ii. Wants to address the \$280,000 left in unrestricted
    - 1. Some possible plans to deal with this:
      - 1.) Allocate on the 2021 budget a much higher amount for the club funding budget to give clubs that were negatively affected this semester a startup amount for next semester. Thinking of around \$1,000 for each of the 134.
      - 2.) Giving all the clubs for the next semester \$500 in seed money expecting for 200 clubs.
        - Jacquelyn said that she feels that only the clubs that were able to get the funding from last semester should get the extra money for the next academic year.
        - ii. Teady agrees with this point because it is our budget and not the universities budget. Would rather support clubs that had

- vi. Christopher said that he sees the unfortunate times as an opportunity to start giving clubs a starting amount of seed money.
- vii. Dena said that they should still go through a process because that is required. There has to be some accountability that they would spend the money.
- viii. Jacquelyn said that Dena makes a valid point about giving out the \$1,000 without a process. Would like Tu to come up with a process for the seed money. When they still come in for a process, we still have ties with the clubs and organizations
- ix. Christopher said that an easy way to have a process for it is to just add \$1,000 to their cap because then they would still have to go through.
- x. Jacquelyn asked how it would be allocated in the budget. Is it coming from the next years budget or is it going to come from the unrestricted.
- xi. Dena said that the goal of the committee is to prepare a 2021 budget that will be able to start the next year. How can we finish this year with the surplus \$280,000.
- xii. Christopher said that he would like to find a way to get clubs their money before the 3&9.
- xiii. Diana talked about in response to the process. She said that if we are supposed to repaying the clubs, why should they go through another process. Also was wondering what the process would look like in terms of difficulty.
- xiv. David said that the \$1,000 could be split into \$500 for each semester. He said that his

- xv. Jacquelyn said that on top of the point of impaction, a lot of the ASI presidents in the CSU have been worried about how many people are going to be still enrolled which might destroy their budgets. She believes that it would be better to come out of this years budget.
- xvi. Betty said that she agrees with Diana. We can honor the commitment made by clubs before the cancellation.
- xvii. Dena said that she agrees with Betty. Said that we could give the clubs that requested money their amounts because they went through the process already
- xviii. Christopher said he is an interesting thing to think about but is not 100% with the idea because we would be giving some clubs a lot of funds that would not be spent at all.
- xix. Jacquelyn said that she is not comfortable with the rollover because we cannot control what the next administration uses it for. The whole intention of using the clubs and organizations is not guaranteed to be fulfilled.
- xx. Christopher said that he does not think that we should be entirely discourage by the chance that they can change the amount.
- Proposals thrown around at the last brainstorming session.Would like to go through the funding amounts for the initiatives
  - 1.) Gift cards for competitions.
  - 2.) Christopher asked how much they were thinking for the gift cards.

- 6.) Christopher said that further on the topic of construction, he said that it is up to the talk with Jacquelyn and Lisa Chavez about construction on campus.
- 7.) Jacquelyn said that it would be good if we can spend our excess money, we should only focus it on one project. We should be strategic to see how we can allocate money towards the students
- 8.) Dena said that we can spend money next year that it is on this year's budget because a project has not been finished yet.
- 9.) Christopher said he would like to find a balance on spending money on students and spending money on ASI
- 10.) Jacquelyn said that she was wondering if we could set up a scholarship fund for students.
- 11.) Dena said that if we do set one up, it would affect their scholarships and financial aid. In addition, the deadline was January 31 to set up any scholarships
- 12.) Teady was wondering if we were still doing the iPads or not because we took so much time to talk about.
- 13.) Jacquelyn said that we technically have not progressed because we have not made a decision on what we exactly want.
- 14.) Christopher said that we should try to support large projects that will help students. Had in mind supporting diplomas for graduates
- 15.) Dena asked if we could allocated money to the book voucher so that students can buy graduation items
