A. ECST summer launch funding proposal – \$4,600 (reimbursement)

Thelma Federico presented (at around 12:14) she is requesting funding that we have previously funded. It's for Launchpad which is a program that increases the number of females who come into the STEM program. This increases the visibility to female students such as available opportunities to them. Student facilitators can serve as role models in the process for teaching about Launchpad. It is for females in high school. There is so much more to all these fields and this program helps females engage and gain the experience through personal reflection. Exploration of different career options and they get to have fun and make new friends. Broadens the possibility students going into this field in which there is a shortage across the board in these fields. Some sponsors have been Boeing, LADWP, Aerojet Rocketdyne, and the Weingart Foundation amongst others. Supports about 5 of their student facilitators last summer they served over 90 students. This year they want to double the amount of students served so any support system is beneficial.

Dena, do you receive any funding from your department. Thelma says no this is sponsor-based.
