Also explains the fees and costs of operations and net shares, interest, and revenue.

Goes over corporate costs and agreements with the Union and charges. Student Government costs like travel and budgets and speaks on how some campuses are still virtual, but we are not.

**Amanda**: Explains more about the textbook scholarship and how they have broken it into 2 semesters.

**Dena**: Explains it is a good program and the students like it.

**Andrew**: Questions on why the 30 students were turned down? Was it from the incompletion of the applications?

**Amanda**: If they didn't qualify, it was because they weren't a full-time student and either didn't have the funds there was 35 that weren't full-time and about 10 who just didn't qualify.

**Sasha**: Questions if we had more applicants/students can we increase the money? Dena: Explains and answers, yes, we can increase the money, but that is something leaders must make and think on. Shares on the leader's advocacy budget go into detail on the student assistant position and removed it from the PR but also since the school is moving back to campus. Shares how, pre-pandemic, there were opportunities with an alternative break which was a service-learning program where we had to travel to places like Peru, which Amanda had attended

**Amanda**: Shares it was physical labor and built a building and learned their culture.

**Dena**: Shares because of the pandemic, they don't know if they can still do that, so they moved that money. Marketing and housing, they put it to PRMC. Explains the communities and their \$25 incentive per meeting they attend.

**Jaime**: Asks how many meetings a committee member can sit on. A student had asked him about the incentive, and yes, they do make money based on the number of meetings they attend.

**Dena:** Yes, and explains more, ASI is offering an award that will be offered in the spring, and how we might still have it. Programs like veterans, childcare, and dreamers, and we give them funding.

Jaime: Question on the dollar difference for something

**Dena:** It is rounding

**Curtis**: Can we move back to support on the student service wants to know if we can fill that for the student's basic needs.

**Dena**: We can talk more, but we need the dean of students to present and ask

**Barnaby**: Shares the Dean of students they need to come to us, they are at their funding, but it is for them to decide. Explains we don't fund unless there is a request there needs to be a purpose & request.

**Dena**: Shares for funding, we have programming and giving back to the students like activities, the scholarship, and the movie nights that is ASI giving back
