b. Club Funding Price List

Barnaby: Explains the structure of the price list.

Yahir: Asks for clarification about travel and lodging.

Barnaby: Explains the policy is still priced at 70%, and there are limitations. For example, for lodging, there's a limitation of \$75 a night, and for airfare, 70% of the full cost is funded, same goes for mileage. This committee's responsibility to approve this price list on an annual basis. So, the maximum has been and continues to be based on this \$3,000 per semester for hospitality. This hasn't changed the flow a bit, but we have updated the figures. So, breakfast based on \$15 per person \$20 for lunch and dinner. I will consider modifying reasonable speaker fees and honorarium based on basically the end of that. So, if you're asking for a \$10,000 speaker and you're wanting it as a club event for 20 people, this committee has to take that into consideration. performance contracts may be required for performers and speakers. And then we may fund clubs, gifts and gift cards and play some fees. ASI can fund up to 1--% of merchandise that's purchased a handout at an activity or event.

Yahir: Asks how to make flyers and marketing more accessible for students.

Barnaby: The marketing team and front desk can make copies. For equipment section rentals, we allow for rentals not purchases. Rentals are regulated and contracted. I will make the language clearer.

c. Reallocation of Program Dollars

Barnaby: In our annual budget, we've approved \$100,000 for programming across multiple areas. We have kind of your marked allocations, but these are not hard and fast allocations. It's kind of like our internal numbers. So, these are somewhat flexible. But you can see here that community engagement and outreach under that section and under that committee that we have, there's a total of \$38,400 that's currently in the budget, and it breaks down with the poster invasion and commissioners' programs. So, EPC has \$2,000 and veterans has \$2,000 in spirit private initiatives which has several traditional events that we put in there, but those change annually. Each of the college reps is allocated roughly \$2,000 a year. Legislative Affairs committee has \$10,250 and then we also have Diversity Inclusion and Civic Engagement, with an allocation of \$11,000. So, these numbers have changed slightly the total moving to diversity programs up to total for CEOs have \$50,000.

Yahir: Shares his concerns about the budget for the DNI officer position.

Jared: Asks about how the budget of \$100,000 has been chosen each year.

Barnaby: Explains that the average funding amount hasn't been changed in a long time.
