- Carmen Gachupin explains the Parking Tax in Los Angeles. She states that she receives letters from the city of Los
  Angeles to pay taxes and her response would be that Cal State LA was a state and entity and therefore exempt. She then
  shares what happened with UC San Francisco where they were not successful in being exempt from the parking tax. She
  then shares that the city of Los Angeles stated that Cal State LA is not exempt because of a supreme court ruling.
- She then elaborates how the taxes changed the parking cost.
- Jared shares that he appreciated her transparency and asks the estimated time it will take to pay off the loan for the new parking lot building.
- Carmen shares how the loan works and it is estimated to be 30 years.
- Dena asks about housing students and how that affects them and offers some solutions.
- Carmen shares that since the housing students are considered residents, they don't get charged the LA parking Tax.
- Andrews shares that he has heard students complaining about the parking system. He asks if it's possible to make the
  processes simpler.
- Carmen shares how it works and how it has been simplified.
- Jared asks if it's possible to put down the parking pass prices.
- Carmen shares that the parking permits are probated, and prices change as time goes by.
- Santhosh shares that he was told that there are not enough charging stations and if it's possible to add more.
- Carmen confirms that they are working with a vendor to get more charging stations.
- Chief Bohannon goes over safety upgrades that will be done for the parking lot.
