- a. January 2024 Financials

Dena: Transparent about the 2024 January Financials and explains that ASI is on a trailer system, so our budget is based on the revenues we collected last year. This year to date, we received a check for \$630,000. This will be a kickoff to our 24-25 budget. For the personnel expenses, you'll see the budget, the year-to-date costs in the middle column, what's available left to spend, and a percentage on the far-right column. The use of reserves will change because you've already approved this budget so the use of reserves will go down.

- Barnaby Peake: He will reach out to the library to get the statistics on SCORE from what ASI funded. The 6&6 moves to the board for final approval next week. For next year's budget, there will be a decrease in out fee revenue so that is a big topic of conversation.
