III. Action Items

➤ **Certification of ASI Election – Election Commissioner**

- Udayshy Chugh states “Voting for Elections took place Friday, April 12 through Tuesday, April 16 using the online GET portal. The review of the electronic polls occurred on Wednesday, April 17 using the GET system. The Dean of Students office reports all results are valid. 708 students voted electronically via the Golden Eagle Territory (GET) system, representing 3% of Cal State LA student body. No major concerns with the voting process were reported during the voting process. The GET portal had some configuration issues preventing students from voting first thing Friday morning, which was fixed by noon that day. Unfortunately, a critical maintenance update for GET was scheduled Friday night and students could not vote for a period of time when the system was being updated. This was announced via campus email just days before the voting was to occur and ASI requested IT change the date of the update, but a delay was not possible. No campaign evidence were reported during the campaign period. The election process was fair and a success and the ballot tally is accurate. Based on this review of the process, I recommend the Board make a motion to certify the election as I have presented today.”
- Yadira asks if there are other ways to vote for students to vote?
- Udayshy explains that would require a third party hire and GET is the easiest and guarantees authenticity.
- Ashley shares that ASI is looking for other reliable ways to vote.
