# > 2024-2025 Budget

Dena Florez: Asks if anyone has any questions for any of the sections, we won't go line by line as we did that at the last Finance meeting.

Andrew Klein: Asked if there is a chance the revenue (student fees) can go up or is this the final number?

Dena Florez answered, there will be a reconciliation over the summer to see if any additional fees are due to us.

Yahir Flores: Talks about how he was brought this up last time but he does not agree with the 3% increase for pro staff. He values and appreciates the pro staff commitment, however; the holistic picture and the reallocation and decreasing in some of the other line items (student gov. travel, programming). Does not believe this is the right time, and we can relook at this at the 3&9 budget. We need to prioritize the other areas for now.

Santhosh Kumar: Asked is the budget has a 3% or 5% increase?

Dena Florez answers, the budget represents 3%. Additionally, this is just a plan to start the 2024-2025 year. This can change and knows that we want to represent the students as much as we can. By the 3&9 budget, we will have an audit and reconciliation of student fees which will led to additional revenue.

Dena continued, goes through the difference between a 0%, 3%, and 5% salary increase. If we do wait until the 3&9, it would need to be retro to July 1st.

Santhosh Kumar: Says since cost of living is going up, there should be 5% increase for all positions - GIA

Jared Blanco: Asked for a clarifying question to Yahir – you want to hold off on the 3% for the staff now until the 3&9.

Yahir Flores: he proposes no increase right now and later down in the academic year to take another look at it

Dena Florez: Clarified if you approve the budget as is, it already includes the 3%. If you want no increase, there would need to be a motion and then reapprove.

Gus Salazar: Mentions that when he started that was the narrative and have been the narrative for many years – it's not the right time for an increase let's hold off.

Santhosh Kumar: Asked the committee if they are open to a 3% increase for GIAs

Cindy Nguyen: We don't want to increase what we pull from reserves; she doesn't believe this is the right time for GIAs since there are higher priorities and GIAs are stipends

Carlos Beltran: As leaders, employee retention is the most important thing and fairly compensated is a high priority. The rest of the campus is getting a 5% increase.

Arwa Hammad: Amends for a 5% increase for staff

Motion dies – no one seconds

Santhosh Kumar: Amends for a 5% increase for staff and 3% for GIAs

Arwa Hammad: Discussed that GIA are stipends and are different then staff salaries, the GIA is supposed to assist.

Santhosh Kumar: Said tuition is going up 5% and the 5% increase can help supplement the cost.

Cindy Nguyen: Mentioned the 5% tuition increase is for all students, and we aren't reimbursing all students the 5% and GIA is a stipend and an assist and not an employee salary that you live off.

Jenny Lucas: Mentions we don't want students to come to ASI for the money, the purpose is to advocate for students and their concerns.

Yahir Flores: Mentions that tuition is going up systemwide, and it is about quality work for the students. The students are the ones who pay for our GIAs.

Santhosh Kumar: Said the ASI fee is insignificant compared to the overall tuition fees students pay.

Yahir Flores: Explain that this is significant. Any fee is significant for students.

Dena Florez: Agrees that this is an area that needs to be looked at. It is used to help subsidize college costs. This is just a plan.

Andrew Klein: Call to Question on this amendment to raise the GIA by 3% and Staff salaries by 5%. Roll Call Vote:
