Barnaby: Shared it would be up to the committee to decide when the end the semester would be.

Leslie: Shared this request should be funded since the last day of the semester is the 24th and it's the last meeting of the year we should give out as much money back to the students.

Amanda: Shared that the students have not been chosen, a sign up will be sent with some questions. The request is for registration for 11 students because that is the maximum amount that gets them to the \$3,500.

Daniel and Arwa: Both shared their concerns on how the 11 students will be chosen and if it is open to all Cal State LA students.

Yahir: Shared we are here to fund the student organization, and it is up to them to choose the best students they feel will benefit. Also, they have an advisor that most likely helps them coordinate and provides input. The registration is for Cal State LA students, and the conference is tailored to a discipline so it would make sense to send students who are in that discipline and can benefit the most from the conference.

V. Discussion Items

A. Impact Report

Alonso: Shared he sent an email out to the committee asking some questions related to the committee and RSO funding and he will read through them and compile it and send it over to Yahir and Cindy for the full ASI impact report.

Arwa: Asked for clarification and what should be included.

Alonso: Answered and provided more insights, he wants to hear from each committee member what was the most impacted moment for them and why (ex. funding RSO's, ASI budget conversations, policy changes).

Yahir: Shared to Alonso what he is looking for, for the Finance Committee impact report - work with Amanda to receive data (how many RSO's we funded, total amount, total number of events, the type of RSO's - academic,

social, etc.) that he can include. Can also include testimonies, from RSO's who have received funding from ASI and how it helped their student organization.

Frangelo: Asked a question - Is the student organizations surveyed after they receive reimbursement?

Barnaby: Answered - a survey is currently getting developed and will be sent out in the next couple of weeks.

VI. Reports

Alonso: Shared he is working on the impact report and volunteered at Gold & Iron earlier today to help stem gowns.

Yahir: Shared updates from the university budget committee - there were updates to the budget transparency website, Cal State LA's reserve is \$21.3 million and that only represents 5.7% of the total operating budget and that would only cover expenses for 21 days and that is below CSU's ideal reserve which should be 3-6 months of expenses. The university is concerned about IBC funding; the federal government wants to cap it at 15% instead of 46%. IBC support various centers on campus, facilities, administration, sponsored projects, academic departments, this all can be affected if they do lower the cap. Additionally, the university is looking forward to see the Governor's May budget revision and once it is released the budget committee will reconvene to make any adjustments and draft the budget to submit it to President Eanes.

Daniel: Mentioned he reached out to the incoming-elected VPUA to schedule a meeting.

Fabi: Shared about the incoming event to recognize the student organizations - Golden Eagle Awards and invited the committee to attend.

Frangelo: Shared the Dean of Students is having a block party on the 4th floor in SSB to destress from finals and invited the committee to come by.

Barnaby: Shared that we will be adding the April's financials to the approved the ASI 25-26 Budget so the university can get an idea to where we are at and then we will send it out for signatures. Additionally, the LAIF interest for this year is \$66,000 and we still have 1 quarter left, it has been averaging around \$22,000 a quarter and this is all additional income and will help the budget
