For equipment they don't plan on spending anything for this year as was by approved by the committee. Reminds them that ASI is a tenant in the building but does not pay rent instead they share the cost or custodians which is going to increase. There will be a decrease in supplies and services as the website has been updated already. GIAs have not been updated since 2018 so they have increased. Childs services and RSO funding/ Co sponsorship have decreased.
