A RESOLUTION IN SUPPORT OF THE MIDDLE CLASS SCHOLARSHIP ASSEMBLY BILLS 1500 & 1501

- WHEREAS, the Associated Students, Incorporated (A.S.I.) is the single recognized voice for nearly 20,000 students at California State University, Los Angeles (CSULA); and
- WHEREAS, A.S.I. recognizes public education is a right and not a privilege and that the promise of free or affordable public education in the California Master Plan for Higher Education is one of the greatest democratic achievements in California's history; and
- WHEREAS, the CSU system has recently suffered a \$750 million cut and is in danger of suffering another \$200 million cut if the California Sales and Income Tax Increase Initiative does not pass as a ballot measure; and
- **WHEREAS,** the budget cuts represent a threat to students' right to a public education, particularly middle class students who face increased fees without the benefit of financial aid; and
- WHEREAS, Since 2003, CSU fees have jumped 191% forcing middle class students, who do not receive financial assistance, to take on heavy debt to get their degree; and
- **WHEREAS**, the Middle Class Scholarship, Assembly Bill 1500 would close a \$1 billion tax loophole that benefit large, out-of-state corporations; and
- **WHEREAS**, the additional revenue would finance scholarships for students whose families make less than \$150,000 a year but earn too much to qualify for financial aid; and
- WHEREAS, the Middle Class Scholarship, Assembly Bill 1501 would add the Middle Class Scholarship to the education code and help cover 2/3rds of student tuition for families that make less than \$150,000 a year; and
- **WHEREAS**, approximately 150,000 California State University students could be affected by the plan and if eligible, could receive approximately \$4,000 per year to assist with tuition cost; therefore, let it be
- **RESOLVED**, that the A.S.I. supports the Middle Class Scholarship with a commitment of no more than 10% of their resources going towards monetary support of the initiative's campaign; and let it also be



- **RESOLVED,** that the A.S.I. urges all student governments in the CSU systems to support the Middle Class Scholarship and to mobilize their volunteers in their lobbying efforts; and let it finally be
- **RESOLVED,** that copies of this Resolution be distributed widely, including, but not limited to CSU Chancellor Charles B. Reed, the CSU Board of Trustees, the California State Student Association, the offices of all Associated Students within the CSU system, the offices of all CSU Presidents, the CSULA University Times, Speaker of the California Assembly John Peréz, and California Governor Jerry Brown to inform them of the A.S.I. commitment to supporting this initiative.
