

## A RESOLUTION IN SUPPORT OF THE CAL STATE LA DEAD-HOUR

The Associated Students, Incorporated (A.S.I.), the single recognized voice for nearly 27,000 students at California State University, Los Angeles, was engaged by our constituents and asked to study the impact of losing a daily dead-hour - the block in time in which most students do not have class.

- **WHEREAS,** A.S.I. sees the value in the dead-hour (from 3:10 p.m. to 4:20 p.m. daily) as a crucial time for student involvement; and
- **WHEREAS**, the dead-hour promotes campus unity through utilization of resource-specific events that enhance student interaction; and
- WHEREAS, the dead-hour accommodates faculty office hours and accessibility; and
- **WHEREAS**, academic studies have shown considerable increases in student performance when proper breaks are afforded<sup>1</sup>; and
- **WHEREAS**, dead-hour is vital for students to work collaboratively to attain their educational goals and complete group projects; and
- WHEREAS, the University has failed to provide any evidence of potential cost savings or academic benefits derived from severely limiting the availability of dead-hour; and
- WHEREAS, some students with a Monday, Wednesday, Friday schedule will not be able to take advantage of the dead-hour if it is only offered on Tuesdays and Thursdays; and
- WHEREAS, A.S.I. believes that changing the dead-hour structure to an hour and forty minute block only twice per week will adversely affect student involvement and student success; let it be
- **RESOLVED,** that the A.S.I. Board of Directors takes a formal stance in support of a daily deadhour model and encourages the Cal State LA Academic Senate to develop a class

- **RESOLVED**, that the Academic Senate consider the dead-hour be renamed as "Activity Hour" to reflect its purpose as a means for student participation and involvement; and be it finally
- RESOLVED, that copies of this resolution be distributed widely, including, but not limited to, CSU Board of Trustees, CSU Chancellor Timothy P. White, the California State Student Association, the California Faculty Association, the Cal State LA Campus President Dr. William A. Covino, the Cal State LA Academic Senate, and the Cal State LA University Times.
